Sir,

In producing herewith one accused person named Vishnu Buddhathoki (58), S/O- Lt. Babulal Buddhathoki of Durga Hotel, Siliguri Junction, Ward No 01, PS Pradhan Nagar, Dist Darjeeling under arrest along with following articles under proper seizure.

1] 18 (Eighteen) bottles of Kingfisher Beer Strong (each bottle containing 650 ml, Total 11.7 liters) and marked as "exhibit A"

2] One bottle of Kingfisher Beer Strong taken out from 'exhibit -A' as sample for examination and marked as "exhibit A-1".

3] 02 (Bottles) of Royal Stag Blended Whisky each bottle containing 750 ml, Total 1.5 liters) and marked as "exhibit B"

4] One bottle of Royal Stag Blended Whisky taken out from 'exhibit -B' as sample for examination and marked as "exhibit B-1".

5] 02 (Bottles) of Imperial Blue Classic Grain Whisky each bottle containing 750 ml, Total 1.5 liters) and marked as "exhibit D"

6] One bottle of Royal Stag Blended Whisky taken out from 'exhibit -B' as sample for examination and marked as "exhibit D-1".

I, SI Abhishek Theengh of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Vishnu Buddhathoki (58), S/O- Lt. Babulal Buddhathoki of Durga Hotel, Siliguri Junction, Ward No 01, PS Pradhan Nagar, Dist Darjeeling to the effect that today on 01.12.2022 at 20:15 hrs received a source information that one person named Vishnu Buddhathoki is selling liquor in shop situated at Siliguri Junction under Pradhan Nagar Police Station without any valid license. Accordingly, I informed the matter to you and as per your kind direction myself along with CV/128 Ajay Kr. Sahani, CV-223 Swapan Chettri had been to Siliguri Junction under Pradhan Nagar PS to verify the veracity of the information.

On reaching there and as identified by the source it found that one person was selling and storing liquor at his shop. Subsequently, I along with my force cordoned the shop styled as Durga Hotel and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that the owner of the shop is Roshan Lama. Further being searched the above noted seized articles were found in the said shop. On demand he failed to produce any valid license/papers for selling and storing of such articles.

On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06(six) months for his illegal gain. Then I seized and labeled the above-mentioned liquor under proper seizure list in presence of independent witnesses and arrested the above-mentioned person named Vishnu Buddhathoki (58), S/O- Lt. Babulal Buddhathoki of Durga Hotel, Siliguri Junction, Ward No 01, PS Pradhan Nagar, Dist Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 20:25 hrs to 21.05 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Vishnu Buddhathoki (58), S/O- Lt. Babulal Buddhathoki of Durga Hotel, Siliguri Junction, Ward No 01, PS Pradhan Nagar, Dist Darjeeling and the owner of the shop namely Roshan Lama of Durga Hotel, Siliguri Junction, Ward No 01, PS Pradhan Nagar, Dist Darjeeling of under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
