Respected Sir,

With utmost respect, I, BHUPEN CINTURY, son of Late Rajen Kumar Cintury, resident of Arithang, P.O & P.S Gangtok – 737101, Dist. Gangtok, Sikkim, would like to inform your good-self as under:-

- 1. That, Mr. BABLU MANDAL, son of Shri KARTICK MANDAL, permanent resident of Baikunthapally, SMC Ward No. 41, P.O Sevoke Road 734001, P.S Bhaktinagar, Dist. Jalpaiguri and currently residing at Ravongla, Dist. Namchi, Sikkim, is my friend.
- 2. That, during December, 2020, said Mr. BABLU MANDAL, he offered me to sell the under mentioned landed property duly recorded and registered in the name of his father Shri KARTICK MANDAL:
- 3. Sheet No. R.S. 14, Khatian No. R.S. 311, L.R. P-90, Plot No. R.S. 19 L.R. 579 \* 580, measuring 05 Kathas, locate at Pargna Baikunthapur, Mouza Jungle Mohal, J.L. No. 1, Police Station Bhaktinagar, ADSR Office Bhaktinagar, Dist. Jalpaiguri, W.B.
- 4. That, said Mr. BABLU MANDAL often telling me that he is selling the said plot at nominal rate to me and he being my friend I have accepted the proposal and decided to purchase the said plot @ Rs. 3.30 lakhs per katha.
- 5. That, on the 26th day of December, 2020, I have paid a sum of Rs. 4.00 Lakhs only in cash to the landowner Shri KARTICK MANDAL as advance money in presence of said Mr. BABLU MANDAL and other family members. Accordingly, the DEED OF AGREEMENT FOR SALE OF LAND (BAINAMA) was executed in between me and the landowner Shri KARTICK MANDAL on dated 26th December, 2020.
- 6. That, during the month of January, 2021, I have also paid a sum of Rs. 30,000/- (Rupees thirty thousand only) as second advance money on account of said Shri KARTICK MANDAL, through online payment. But, in the meantime I came to know that the rate of the said land is very high. Mr. BABLU

MANDAL, being my close friend I have trusted him, but taking advantage of our friendship trust he had mislead me. Such being the case, I have decided to cancel the deal and requested them to refund the paid advance money.

- 7. That, in Page 04, Para 01 of the said Deed of Agreement for Sale of Land it is clearly mentioned that "the advance money amount will be refunded after expiry of stipulated period". But, said Shri KARTICK MANDAL, did not refund my money (advance paid of Rs. 4.30 Lakhs). He started giving me emotional blackmail by saying he is a heart patient and will refund my money after selling the said land to another party.
- 8. That, soon later I am surprised to know that the said land has been sold out to another person / third party and the third party has constructed boundary wall / shed during August, 2022.
- 9. That, said Shri KARTICK MANDAL and his son had sold out the said landed property to the Third Party without my knowledge and consent, and against my request for refund of advance money they misbehaved me and directly said that they will not refund the advance money. They also threatened me.
  - 10. That, till date I have requested several times to said Shri KARTICK MANDAL and his son for refund of advance money, but they are not listening me, and I am facing great mental torture and harassment.

I, therefore, request your good-self to be kind enough to look into this matter seriously and kindly take a necessary action against said Shri KARTICK MANDAL and his son for cheating me and giving mental torture & harassment. Further, do needful for refund of my advance money as mentioned hereinabove with due and proper justice.
