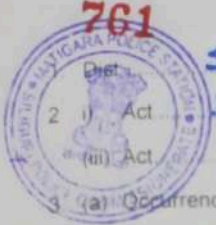

Respected Sir,

I, **SANJAY RAM**, son of Late Panchan Ram, resident at Kholai Bakhtari Bhutta Khet, Tumba, Matigara, under Matigara-II Gram Panchayat Area, Police Station: Matigara, Distt. Darjeeling, in the State of West Bengal would like to inform you for your kind information and necessary legal action as follows:-

1. That I reside at my aforesaid address along with my wife, three Daughters & son.
2. That one person namely Manik Sahani, Son of Lt. Debendra Sahani, residence at Santoshi Nagar, Machhali more, Ward No.5 of SMC, Police Station: Siliguri, Distt. Darjeeling was introduced in the year 2014 to my daughter namely Miss Khusbu Ram at Machhali more, Santoshi Nagar, where Badal Sir had taken Dance Class namely Ninja and my daughter was study in class VIII.
3. That my said elder daughter namely Miss Khusbu Ram, now aged about 24 years had been engaged for marriage in the month of February, 2022 with Dipak Ram, son of Sri Sahdeo Ram residence at Phansidewa more, Shivmandir, P.S. Matigara, Distt. Darjeeling and the date of marriage has been fixed in the month of February, 2023.
4. That Monday on 14-11-2022 at about 11:00 a.m. my daughter Miss Khusbu Ram has gone Suryasen College, Deshbandhupara, under NJP Police Station for Part-III exam purpose and in the evening at about 8:30 p.m. one message was received from my daughter's mob. No.95470-85062, she was married to Mr. Manik Sahani I therefore searching in all effort but lastly I knew from Manik Sahani's mother they are (my daughter & Manik Sahani) reached in Manjhaul, Distt. Begusarai, Bihar by train and they again married in the Temple in Manjhaul, Begusarai as per their Pictures & video.
5. That after on 18-11-2022 at about 2:30 p.m. Manik Sahani has informed me through telephonic call that Khusbu is in Jalpaimore near river band of Mahananda river and I found my Daughter is in unconscious condition and I with the help of my wishers anyhow take the custody from their trap.
6. That thereafter when my daughter recovered then she said her statements to me that Manik Sahani call through mobile phone on 14-11-2022 and

asked to my daughter where are you ? Then my daughter said she is in college for exam purpose then Manik came at my college and said sit in the back of my Scooty when my daughter said why then Manik said matter is urgency then she sit and both are reached near NJP Railway station the Manik has offer Sweets and said he has found a job with handsome salary and when my daughter has intake the sweets after few minutes She was unconscious and after that what happened to my daughter she do not knew and she has seen her head is in Sindur and is in Bihar then Manik Sahani told to my daughter he has now married couple and if my daughter refused then Manik and his associates kidnapped her two younger's sister and defame her father as well as her family in the society, the Manik Sahani and his uncle who is reside at Begusarai, Bihar and their associates again exchanged the garland at in the temple at Manjhaul, Distt. Begusarai, in the State of Bihar by forcibly and blackmailed by Manik Sahani and their associates and the marriage was illegal and at the time my said daughter was in unconscious.

7. That yesterday Dated: 22-11-2022 in the evening at about 8:00 p.m. Manik Sahani, Bipin Sahani, Rajkumar Sahani, Suraj, Akash and 8 to 10 person their associate in from bike and scooty came at drinking conditions at my aforesaid residence and Manik Sahani ask where is my wife ? if not produce in front of his within 24 hours then they are dangerous and when required they will not hesitate to kill my said daughter or other family member.

Respected Sir, I knew from my wishers that Mr. Manik Sahani and their family members i.e., mother, two brother's Bipin Sahani & Raj kumar Sahani are drug edict and illegal drug paddler; they any how want to trap in their clutch of my said daughter and thereafter their dream to illegal demand or sell my daughter to another person.

So, under the above circumstances I therefore request you kindly enquire the matter and immediate arrest the accused persons **1.Mr. Manik Sahani, 2.Mr. Bipin Sahani, 3. Mr. Raj Kumar Sahani, 4. Mother of Manik Sahani, 5.Mr. Suraj, 6. Mr. Aakash** and their friends and associates as per provision of law and save my family from their ill motive. And for this act of kindness I shall always obliged you.
