Sir,

In producing herewith 01 (one) arrested accused person namely Anand Panna(35), S/O- Abanu Panna of Shibmandir, PO- Kadamtala, PS- Matigara, Dist- Darjeeling along with following articles under proper seizure.

1) 23(Twenty three) bottles of Super Jubilee special Whisky, each bottle containing 375 ml, total 23X375ML= 8.625 Liters and marked as "exhibit- A" .

2) One bottle of Super Jubilee special Whisky containing 375 ml which was taken out from "exhibit-A" as sample for examination and marked as "exhibit A-1"

I, SI Uday Chakraborty presently posted at Matigara Police Station, Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person that today (01.12.2022) at 18.45hrs onwards while performing evening patrolling duty I received a specific source information that one Anand Panna is selling and storing huge quantity of illegal liquor at his residence situated at Shibmandir, under PS- Matigara. Accordingly, I informed the fact to the Officer-In-Charge and as per his direction myself along with force left for Shibmandir, under PS- Matigara to work out the information in hand by Govt. vehicle. After arrival at the spot and as identified by the source I held raid at the house of Anand Panna(35), S/O- Abu Panna of Shibmandir, PO- Kadamtala, PS- Matigara, Dist- Darjeeling and managed to detain him. On being asked the detained person named Anand Panna stated that he is the owner of the house. On being asked search the above noted seized articles are found inside the house. On demand he failed to produce any valid license/papers for selling and storing of such articles. Then, I seized the above mentioned articles under proper seizure list and subsequently arrested the above mentioned person under proper memo of arrest, observing all sorts of formalities. On further interrogation of the arrested accused person namely Anand Panna it could be learnt that he is involved in selling and possessing the liquor without any valid license for his illegal gain. The seizure has been made on 01.12.2022 in between 19.35 hrs to 20.35 hrs.

Under the above noted fact and circumstances, I, therefore pray before your good self that a specific case under proper section of law may kindly be initiated against the above noted arrested accused person namely Anand Panna(35), S/O- Abanu Panna of Shibmandir, PO- Kadamtala, PS- Matigara, Dist- Darjeeling and arrange for its investigation.
