I, **Sudama Kumar**, Son of Sri Halkori Sah, residence at Sukantapally, Darjeeling More, Post Office & Police Station: Pradhan Nagar, Siliguri, Distt. Darjeeling, in the State of West Bengal would like to request you for your kind information and necessary action as follows:-

1. That I am working as Salesman in Petrol Pump namely "MAA DURGA FUEL SERVICE" at Devidanga, Champasari, Police Station: Pradhan Nagar, Siliguri, Distt. Darjeeling.
2. That today dated 01-12-2022 in the evening at about 6 p.m. one person namely Rohit, son of not known, residence at the locality of Devidanga, Pradhan Nagar, Siliguri drive one white Colour Maruti Swift and came at our above named Petrol Pump and told me fill Rs.520/- (Rupees Five Hundred and Twenty) only Petrol in his said vehicle and I have filled for same amount. Thereafter Mr. Rohit and his friend Dipu Kamti who was sit in the vehicle without any causes using filthy languages against me and my Petrol pump owner namely Ajit Kumar Singh then I told him why without any causes you are using this type of slang languages then they immediate get off from their said vehicle and suddenly try to snatch the cash amount from me and also started to hit with feast and blow in my abdomen and when my colleague namely Sumit Singh came and obstruct their illegal activity then they (Rohit and Dipu Kamti) also bitten to my said colleague who is working that time in said Petrol Pump. Dear Sir I have seen in the said vehicle one unknown person he has a Pistol and the said person has aim in my head and they any how try to loot the cash amount by the point of Pistol from my said Petrol Pump but when I and my other colleagues who is working that time cry loudly then they are fled from my Petrol Pump with threaten me for dire consequences against me and my colleagues.

So, under the above circumstances I humbly request you kindly enquire the matter and to take necessary legal action against the said accused persons namely **Rohit, Dipu Kamti and one unknown anti social person** who sit in the said vehicle and also save me or my life as per provision of law. And for this act of kindness I shall always obliged to you.
