I, Smt. Mani Barman(Baroi), W/O Sri Pintu @ Bittu Barman, D/O Sri Manoranjan Baroi now resident of C/O Manoranjan Baroi, Durga Nagar ,Kumartuli, Ward No.4, Siliguri Municipal Corporation, Dist. Darjeeling, do hereby lodge this FIR to the effect that on 28/2/2014, I was married to Sri Pintu Barman , S/O Lt. Amit Barman, permanent resident of Dasarathpalli, near Check Post, Ward No.44, P.S. Bhaktinagar Dist. Jalpaiguri, who is a tailor by occupation . The marriage took place under Hindu rites and customs at the house of relative of my husband at Gurungbasti, Siliguri, Dist. Darjeeling.

After marriage, I started living with my husband and brother in law Sri Subrata Barman and his wife in my matrimonial house at Dasarathpalli, near Check Post, Ward No.44, P.S. Bhaktinagar Dist. Jalpaiguri. My two sons Piyush Barman aged about 7 years and Akash Barman aged about 3½ years were born out of the wedlock and are residing with me at present. For the last 3 and half years my husband has been torturing me physically and mentally because my family is not able to fulfill his demands for dowry which he made after my marriage. On the instigation of my said brother in law, my husband increased his demands for money from my family after birth of my second child and although my mother provided him money from time to time he wanted more money and if he did not get money he would beat me up on the instigation of my brother in law.

About six months ago on the instigation of my brother in law, my husband hit me on my head with a stone masala grinder, my mother came and took me to the doctor for first aid for my bleeding injuries on my head. He had threatened to kill me and told me not to come back to my matrimonial house if I did not get more money. My family paid for my day to day needs and even for my children. My husband mixes with unsocial elements and is a habitual drunkard and stays out at night with the hooligans of the locality and does not

pay anything for the maintenance of my children or for me.

Whenever my husband came home he started beating me after demanding money and told me to get money or go away but on 30/11/2022 he again demanded money and when I refused to bring money he took a 'Belni' from kitchen used for making roti and hit me on my head and nose and even hit me on my mouth. He hit me with his fist on my eyes and even tried to strangulate me to kill me.

I and my children started screaming and our neighbours ran into my house and saved me. My elder son called my mother on my mobile and my mother came and took me to the hospital and orally informed local police .I was however admitted in the government hospital after I was taken there and could not file written complaint. I was released from the hospital yesterday and I am filing this complaint today.

My husband and in laws have kept my stridhan with them and I fear that they may misappropriate the same.

Sir, the aforesaid activities of my husband, and brother in law, have gone beyond my tolerance. I have lost all my hopes to resume my matrimonial life any further and I am certain that I will be killed if I return to my matrimonial home. I am now in a helpless condition and I need your help urgently to start appropriate legal action against my husband Sri Pintu Barman, and his brother Sri Subrata Barman.
