Sir, this incident has occurred today between 2:08 pm to 2:13 pm within a span of 5 minutes. I was personally out of town due to some emergency meeting at Darjeeling this morning. I took all the possibilities to relocate them, despite of my best effort, we couldn't retrieve them.

Among the escaped, one girl is my sewing staff of the Centre named Uttama Rai (ID NO 5th page), through her support they fled from the treatment Centre, by opening lock gates and exit door.

Sir, on the context of Fled patients (girls), their parents were informed respectively and one girl from Gangtok named Shanta Chhetri (ID Page 6) has reached home safely. Among my total of 16 patients currently, one patient chose to stay back by not joining them in the wrong actions.

Sir, I'm running the Centre since 2018 July for 4 years and never such incident has occurred since then. Therefore I would earnestly request you the GD may kindly be lodged at your PS and necessary help may kindly be provided to locate them, so all can reach their home safely.

Also would like to inform you that in case needed, we have the CCTV footage of the whole incident which occurred.
