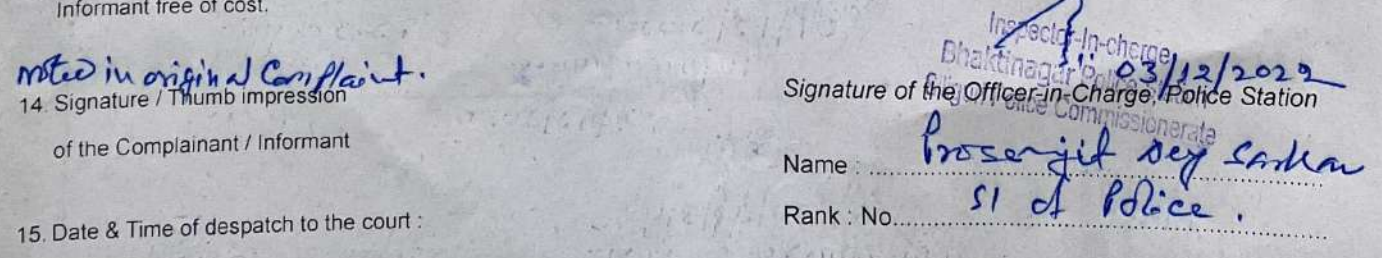

In producing herewith accused persons namely (1) Srabon Paswan (22), S/O- Late Nura Paswan of Purba Hatiadanga Neecha Busty PS Bhaktinagar Dist. Jalpaiguri (2) Sanjay Rajak (34) S/O Debanand Rajak of do and (3) Mahesh Sahani (22) S/O Lakhindar Sahani of Baribhasa Ram Nagar Majdur Busty PS New Jalpaiguri Dist. Jalpaiguri and the following articles under seizure:

i. One old used DELL Laptop and two Sandisk pen drive.

I ASI Ujjal Mandal of Ashighar OP PS Bhaktinagar lodged a written complaint against the accused persons namely (1) Srabon Paswan (22), S/O- Late Nura Paswan of Purba Hatiadanga Neecha Busty PS Bhaktinagar Dist. Jalpaiguri (2) Sanjay Rajak (34) S/O Debanand Rajak of do (3) Mahesh Sahani (22) S/O Lakhindar Sahani of Baribhasa Ram Nagar Majdur Busty PS New Jalpaiguri Dist. Jalpaiguri, (4) Bijay Roy of Purba Hatiadanga neecha busty near Tea Garden and others, to the effect that, on 02.10.2022 I along with C/1181 Bhubesh Ch Roy and CV/909 Nityananda Roy while performing night mobile van duty at Ashighar OP Jurisdiction, Vide Ashighar OP GDE no. 41 Dated 02.12.2022, at 22.40 hrs received a information from ASI Krishna Ch Singha, duty officer of Ashighar OP that he have received information from Control room of Siliguri Police Commissionerate that someone is playing DJ with high volume at Purba Hatiadanga neecha busty near Tea Garden. After receiving this information, at about 22.50 hrs I along with force had been to Purba Hatiadanga neecha busty near Tea Garden and found a family programme (Food intake) was going on at the house of one Bijay Roy and he was playing DJ with high volume at his house. I tried to stop the DJ but the house owner Bijay Roy along with some other people became agitated and started scuffling with us. As a result we sustained injury on our person.. They also damaged the glass of side window of our govt. vehicle. I informed duty officer and asked for re-inforcement. Accordingly at about 23.15 hrs SI Swapan Kr Ghosh, ASI Inzamamul Hoque, ASI Amit Mallick and force arrived at the spot. After seeing the re-enforcement Police team the agitated people started to flee away from the spot. After hot chase we apprehended above noted three persons who disclosed their name and address at noted above and confessed their guilt. I arrested them, issued memo of arrested and informed them the ground of arrest. I also seized one old used DELL Laptop and two Sandisk pen drive which were used for playing DJ, from the house of Bijay Roy. Held raid at the house of Bijay Roy but he flee away to avoid Police arrest.

I therefore pray that specific case may kindly be initiated against the accused persons namely (1) Srabon Paswan (22), S/O- Late Nura Paswan of Purba Hatiadanga Neecha Busty PS Bhaktinagar Dist. Jalpaiguri (2) Sanjay Rajak (34) S/O Debanand Rajak of do and (3) Mahesh Sahani (22) S/O Lakhindar Sahani of Baribhasa Ram Nagar Majdur Busty PS New Jalpaiguri Dist. Jalpaiguri (4) Bijay Roy of Purba Hatiadanga neecha busty near Tea Garden & others and arrange for its investigation.
