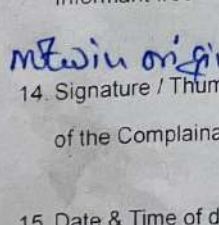

Respected Sir,

I Pawan Kumar Agarwal, 80 late Manu Ram Agarwal, aged 63
years old & owner of the firm Pawan Enterprises situated at Eastern
by pass Road, Chayanpara, Dist Jalpaiguri P.S. Bhaktinagar beg do
approach your good self to the effect that on 01/12/2022 in the
midnight time possibly after the midnight showing in the CCTV
(camera) that one person entered the shop by way of opening the tin
corrugated roof by way of breaking the false ceiling and took away
some cash nearly fifteen to twenty thousand rupees from Ahira
& some valuable hardware items from the shop & fled away.
I noticed the incidence of theft when I opened the shop about
10. a.m in the morning with my staff. The value of hardware items
along with cash money would be approximately thirty to thirty five
thousand, by this incidence we are very anxious about anything
illegal happenings. As I felt ill, so I couldn't raise the complain on day of
incidence that is on 1st Dec, 2022.
It is accordingly prayed that your good self would be kind enough
to investigate into the matter & save our shop from this type
of illegal incidence.


