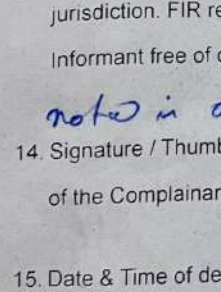

Sir,

In producing herewith the following 03 (three) persons arrested namely 1. Roshan Barman (20Years) S/O- Ramani Barman of Chayan para, Roy Colony, W.No-42, PS-Bhaktinagar, Dist-Jalpaiguri, 2. Biswajit Roy @ Chattu (22 Years) S/O- Domashu Roy of north Ektiashal, Hari mandir, W.No-40, PS-Bhaktinagar, Dist-Jalpaiguri 3. Suman Basumata (23 Years) S/O- Ashish Basumata of Pradhanpara, Salugara, W/N-42, PS-Bhaktinagar, Dist-Jalpaiguri under arrest along with the following seized articles:-

1. One iron rod measuring about 48" in length recovered from the possession of accused Roshan Barman (20Years)
2. One iron rod measuring about 36" in length recovered from the possession of accused Biswajit Roy @ Chattu (22 Years)
3. One iron rod measuring about 46" in length recovered from the possession of accused Suman Basumata (23 Years)

I, SI Rantu Haldar of Bhaktinagar PS/SPC would like to lodge this written complaint against the above noted persons and 5/6 others persons to the effect that today i.e on 03.12.2022 at about 01.05 hours when myself along with PSI Chiranjit Saha, ASI Dipak Karmakar, C/915 Chandra Prakash Adhikary, CV/614 Sumit Kr Roy was performing night mobile duty at that time received a secret source information that a group of 08/09 persons had assembled at Dumping Ground under Bhaktinagar P.S with deadly weapons with a view to commit some heinous crime. Accordingly without waste any time I informed the matter to I/C Bhaktinagar PS over telephone and as per telephonic instruction we rushed to the spot to verify the veracity of the information and to work upon it. On way to the P.O I called one independent witness namely 1. Prabhat Prasad (23 Years) S/O- Ram Prasad of Vivekananda Nagar, W/N-42, P.S- Bhaktinagar, Dist- Jalpaiguri whom we disclosed our motto and identity and asked him to accompany us if any search and seizure is necessary for the purpose. We reached near the spot as directed by the source at about 01.45 hours and stopped at a considerable distance from above noted spot and we started walking towards the P.O with due care so that no one could anticipate our movement at about 02.05 hrs and found a group of 08/09 persons sitting there. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing away. Anyhow, after a hot chase we could able to apprehend the 03(three) above referred accused persons. On interrogation the 03(three) persons disclosed their identity as noted above and confessed 5/6 other persons with them. They had assembled there with a view to commit dacoity after making full preparation in the house of bottle company adjacent areas. Thereafter all the apprehended persons were searched in presence of the witnesses and the following articles were seized.

1. One iron rod measuring about 48" in length recovered from the possession of accused Roshan Barman (20Years)
2. One iron rod measuring about 36" in length recovered from the possession of accused Biswajit Roy @ Chattu (22 Years)
3. One iron rod measuring about 46" in length recovered from the possession of accused Suman Basumata (23 Years)

All the articles were seized between 02.25 hrs to 02.45 hrs issuing a proper seizure list duly signed by the witnesses and the accused persons. Thereafter all the persons were arrested between 02.48 hrs to 02.54 hrs as they had assembled for committing heinous crime.

Under the above circumstances, I pray before you that a specific case U/S 399/402 I.P.C may kindly be started against the 03 (three) persons arrested namely 1. Roshan Barman (20Years) S/O- Ramani Barman of Chayan para, Roy Colony, W.No-42, PS-Bhaktinagar, Dist-Jalpaiguri, 2. Biswajit Roy @ Chattu (22 Years) S/O- Domashu Roy of north Ektiashal, Hari mandir, W.No-40, PS-Bhaktinagar, Dist-Jalpaiguri 3. Suman Basumata (23 Years) S/O-Ashish Basumata of Pradhanpara, Salugara, W/N-42, PS-Bhaktinagar, Dist-Jalpaiguri and 5/6 other persons for assembling with deadly weapons with a view to committing dacoity.
