I, Fulmaya Sunar, age 7 yrs, widow of Late Karma Bahadur Sunar residing at Salugara Bazar, P.O. - Salugara, P.S. - Bhaktinagar, Distt - Jalpaiguri, West Bengal beg to lodge a written complaint against my second son Mr Lila Ram Sunar, age 46 yrs and his wife Mrs Bina Sunar. I have been living at my residence and after the expiry of my husband in 2014, I have given permission to my 2nd son to live ~~in~~ in my building as they showed their incapability of living on rent outside. So I allowed them to stay with me <sup>since</sup> 2020. But my son and his wife started torturing me physically. Three days back they physically forced me out of my own building. They even captured all my valuable property document and all my household goods. This incident has been witnessed by Mr Pratap Biswakarma and Mr Chattu Biswakarma, both of them my neighbours. I am in pain being a senior citizen. Therefore, it is my humble request to lodge a complaint against them and take necessary legal action and vacate my residence at the earliest as possible and oblige.
