I the undersigned do hereby wished to bring it to the knowledge of your esteem office, that on 3rd of December 2022 at around 11:15 PM I long with my two friends went to LEVEL 3, Central Park Building, Sevoke Road, Siligui and after spending few hours we requested the DJ to play one last song at around 2:00 AM on 4th of December 2022.

Sir while we were requesting the DJ to play one last song, suddenly Mr Prince Jain Started Punching and Kicking me and my friend. We requested Mr Jain to stop the Violence he kept on hitting us with his Staffs

Sir after paying the bill which amount to Rs 4844 (Four Thousand Eight Hundred and Forty Four Only ), while we were leaving the PUB they continuously hitting us on the Elevator and in the Parking Passage and during this period Mr Prince Jain and his staffs snatched my Gold Chain which weigh 34 gm and cost approx Rs1,80,000/- ( One Lakh Eighty Thousand Only) along with the cash which i had at that point of time which is approx Rs 45,000/- ( Forty Five Thousand Only )

Sir they also snatched my friend's Scooty's Key and kept it for the whole night. The next morning when I along with my friend went to take back the Scooty, Mr Jain threatened to kill me if I go and file a Police Complaint.

Sir if you could kindly acknowledge this application and bring these Criminals to Justice, I and my friend will be obliged and grateful to you.
