I, Radheyshyam Agarwal, son of Late Ishwar Chand Agarwal, resident of Punjabi para, P.O. & P.S. Siliguri, District Darjeeling would like to state that I am the owner in possession of a land measuring 2.96 acres situated at Khaprail Road, Mouza Panchkulguri, P.S. Matigara, Vill Panchkulguri, Dist Darjeeling which is bounded on all four sides by a boundary wall with security guards to look after the land. The said land is recorded in my name in West Bengal Government land records being LR Khatian no. 195.


Sir, one Nerey Oraon @ Lalchi Oraon son of Late Langra Oraon resident of Gowal Jote, P.S. Matigara, District Darjeeling with the aide of forged and fraudulent documents has been falsely impersonating himself to be the owner of my land. He has prepared forged Death certificate of Budhu Oraon and Jharia Oraon to claim himself to be the legal heir of Budhu Oraon. This forgery was committed by Nerey Oraon with the active participation in criminal conspiracy with one Khemlal Saiboo, son of unknown and Rakesh Saibo son of Khemlal Saiboo and Bishu Oraon, son of Nerey Oraon, who are known land mafia of the area. Nerey Oraon has filed a suit in the Siliguri Court before the Civil Judge, Senior Division being Title Suit no. 99 of 2016 where this documents were filed by Nerey Oraon.

On 01.12.2022, at around 4 p.m. four persons had come to my land. They said four persons informed me that they are in the process of purchasing my land and had paid Nerey Oraon a substantial sum of money who had claimed himself to be the owner of the land. In order to prove his claim, Nerey Oraon, Khemlal Saiboo, Rakesh Saiboo and Bishu Oraon had showed them the forged and fabricated Death certificate of Budhu Oraon and Jharia Oraon. I informed them that I was the owner of

the land and hearing this, they immediately left the area without identifying themselves.

Sir, I would like to say that Nerey Oraon in criminal conspiracy with Khemlal Saiboo, Rakesh Saiboo and Bishu Oraon with the aide of forged and fabricated documents has been fraudulently claiming my land. Further they are deceiving other people of the locality and receiving huge sums of money by fraudulently representing that Nerey Oraon to be the owner of my land despite knowing the true fact that I am the owner of the said land.

Sir, I would kindly request you to look into the matter and initiate appropriate legal action against Nerey Oraon, Khemlal Saiboo, Rakesh Saiboo and Bishu Oraon.
