The cost of 5.5 Katha Land was
Rs 3,85,000/- (Three Lakh Eighty-Five thousand)
for which I paid Rs 2,20,000/- (Two Lakh
Twenty thousand) only cash by hands as a
Token money of Land.

When I gone through searching the land for the above mention plot in B.L.O office at Narabari. I found the land was disputed having two many (Bargadar). I complaints pradip Shaibya for the disputed land. He apoloized and promised me that he will return back all the money which I have paid to him within the month. But almost 5 years have been passed. He didn't give me money completely. I used to go his home daily for my money. But he is not ready to give my money. and said do whatever you can do or go anywhere or to the police station for his complaint

Sir, In this 5 years of period, he gave me some little amount, Now Rs 1,15,000/- (one lakh fifteen thousand) only remaining which he is not ready to give me.

Sir, it is my heartiest request to you. please help me to get back my balance money from Pradip Shaibya and his land partner Robin dorjee who is working together. I am giving you his details contact both.
