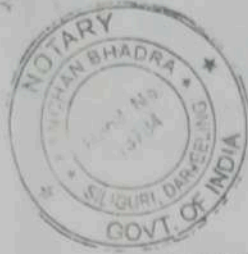

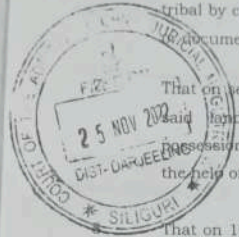

That the above named accused persons prepared false and fabricated documents with the help of anti-social persons and land mafias and are making regular attempts to grab the land of the above named complainant. That the above named complainant is tribal by caste and till today has never entered into any agreement document with the above named accused persons.



That on several dates, several attempts were made to break-in the said land/property of the complainant forcefully grab the possession of the aforesaid land by illegal and violent means with the help of unsocial goons.

That on 16.11.2022 at about 11:00 am the above named accused persons along with 10-15 more anti-social persons came to the complainant's plot of the land with heavy machineries such as bulldozers, Earth Excavators and so on and started working upon the said land, when the complainant raised strong objection they threatened the complainant, slapped him, assaulted him and abused him with filthy language. They even abused me due to my Tribal Caste stating "Tu adhivasi log, Harami Jaat hota hai, Jungle main rehenain jaa.....". They chased the complainant from the said land and threatened him that they shall harm the complainant and won't hesitate to kill the above named complainant. That on the same date the above named complainant went before the Matigara P.S. to lodge one written complaint against the above named accused person and the duty officer accepted and received the said complaint but till date no specific case has been started against the above named accused person. Thereafter finding no other alternative the above named complainant also lodged one written complaint before the Commissioner of Police, Siliguri Metropolitan Police on 17.11.2022 stating the entire facts.
