It is to inform that on 04<sup>th</sup> Dec 2022, written examination in its 2nd shift candidates for the post of Constable (Tradesman) in BSF was conducted in 02 shifts at BSF Sr. Secondary School Kadamtala.

During the 1<sup>st</sup> shift of examination conducted from 10:00 hrs to 12:00 hrs, one of the candidates of the exam sitting in Room No. 35, in the BSF Secondary School, Kadamtala (WB), Pranta Kumar S/o Kamaldev Ray P/o Village- Sundhari, Post- Sundhari, PS- Bhograjpur Pat. Dist- Sivan and State- Bihar having Roll No. 51155546/15, who was appearing in the post of Constable (Cook) was caught along with Mobile Phone (Lava made) in the class room. He was trying to send Question Paper to his companions to get the answers of the questions, by using unfair means. Individual has forwarded 02 to 03 sheets of Question Paper to his companion namely Hare Ram through Whatsapp. Individual tried to break his mobile phone by throwing it on ground, as soon he was caught to destroy the evidence, due to which the mobile phone having IMEI number- 911555355317385 & 911555355317386 got damaged. There was one SIM of Jio Company bearing Serial No. 899185561603319051873 and one memory card of Scan Disk (Micro SD Card of 08 GB memory) in the mobile phone. He was carrying Adhaar Card No. 385489105810, as his Identity Proof.

3. Therefore, it is requested to lodge an FIR against the above individual for using unfair means in the recruitment exam of Border Security Force.
