Respected Sir,

I, Mr. Prosenjit Chakraborty, son of late Kshitish Chandra Chakraborty of Saradamani Road, Ashrampara, Siliguri, SMC ward No.14, P.O. & P.S. Siliguri, Dist. Darjeeling like to state that on 28-11-2022 at about 8.30 P.M. I went to Phuleswari Market for purchase of Cake, Mutton, Vegetables and other grocery items as on that date I arranged a Party of my daughter's birth day.

As I approached at Phuleswari Bazar and Parked my Scottie, one person named Mr. Utpal Sarkar, son of Upendra Kishor Sarkar, resident of Bela Bakery (A.P.C. Sarani, Deshbandhupara, P.O. Siliguri Town, P.S. Siliguri, Dist. Darjeeling, suddenly started abusing me with filthy languages and when I asked him why he is abusing me he started assaulting me with fist and blows, as a result I sustained injuries on my face, hip, chest and legs (kicked me), He also took an iron rod and repeatedly hit me on my back, without any provocation. As a result I fell down on the road. As I am a Patient of High Pressure, so I was advised by the Doctor to take rest, so to day I am filing the F.I.R.

After that I went to Siliguri District Hospital for my treatment and accordingly and the doctor prescribed some medicine (Medical documents) is annexed herewith.

I, therefore request before your goodself to investigate the matter and look the said Utpal Sarkar, son of Upendra Kishor Sarkar according to law and obliged.
