He replied that the person have not reached his place with the money, waiting for the staff to reach either any end, I made a thorow search for the staff at all the expected places he could be but was unable to trace. It seems that he have flew away with the money.

So, I therefor request to lodge a complaint and take necessary step to recover the person along with the cash amount and oblige.
