Sir,

I, Prahlad Rai Toshniwal, am proprietor of M/s Jiwannal Ramlal situated at Nehru Road, Siliguri - 734005 Ward No 8. Our firm is engaged in wholesale trading of tea. We are having a godown at khalpara near Sitla Mandir.

On 19th of November, 2022, we have terminated the service of one of our staff member Mr. Mukesh Ram S/o Bishu Ram residing at Nutan Para Ram Ghat, Siliguri - 734005 Ward No. 5, for his irregular timings at office. We were unaware that he had made a duplicate key of our godown at that time. Today on 2nd December we went to godown for delivery of a lot of tea containing 24 bags tea of 38 Kg each we found that tea was not there in our godown. On viewing the CCTV footage of the godown we found that Mukesh entered the godown at around 7:40 PM with his duplicate teas and took the teas along with one person. His Mobile No. is 81163-37924.

Kindly lodge a FIR against the same and help us to recover our teas.
