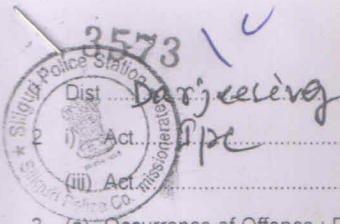

with due respect and humble submission that I Umesh Shankar Prasad Sah s/o Yogendra Prasad R/o Call market ^(Rajabhaiya) Gangtok East-Sikkim would like to inform you that today i.e. - 04.12.2022 at about 7.00 to 8.00 Am near Anara Bank, St. Road, Siliguri, while I came to pick up tourist travellers from Siliguri, on the way to St Road one Bike person collide with my Tourist wagner car bearing number SKOIT 8100 from back side. At that time when I quarrelled with bike person suddenly three person came to near me and attacked me and my car and also beaten me attacked over the head back portion from iron rod and also snatched my golden chain amounting around 3.5 Lacs and my spectacles and also taken ₹ 50,000 (Fifty thousand only) from me and fled away from there including bike person. After that I came to Siliguri Hospital and stitched on my head. So please lodge FIR and take necessary action. Know one of them is Raju Halder.
