

Pin 734005, do hereby appear before you and this complain before you that my brother namely Bhagwati Prasad Pareek is running a business of Merchant and Commission Agent of Clothes under the name and style of M/s. Kalu and Company as proprietor ship, having its business place at Neel Kanth Market, Mahabirsthan, P.O. & P.S. Siliguri, District Darjeeling. That I also used to look after the daily activities of the said Business. That on 03.12.2022 at about 11.30 A.M., I went to the aforesaid business place and found staff namely Subhash Sarkar son of Not known, resident of Poli Mangal Club, Lichutala, P.O., P.S. & District Alipurduar, who used to work since last 3 years and also used to sleep in the aforesaid business place was missing alongwith his all belongings and copies of the documents being given by him to us. Yesterday, at about 9.00 p.m. I had handover a sum of Rs. 5,08,750.00 (Rupees Five Lacs Eight Thousand Seven Hundred Fifty) Only for depositing the same in Accounts of party which were the collection of the said business. I made a diligent search and also rang his mobile no. 8101657243 but it was switch off. After That I contacted at his house at mobile no. 8250486285, but the family member i.e. his wife and son stated that the said Subhash Sarkar had not reached home. And lastly I rang in the said mobile at about 9.16 p.m. on 03.12.2022, but his wife and son stated that the said Subhash Sarkar had not reached home till now and they have no knowledge about the whereabouts of the said Subhash Sarkar and on query about the father name of Subhash Sarkar and their address the son of Subhash Sarkar refused me to provide the name of the father of Subhash Sarkar and their address.

I searched about the said Subhash Sarkar wherever I could but could not trace out the said Subhash Sarkar till now.

Sit, I therefore request you to take necessary actions as per law to search out the said Subhash Sarkar and also to recover the amount of Rs. 5,08,750.00 (Rupees Five Lacs Eight Thousand Seven Hundred Fifty) Only.
