SUB : LODGING OF FIRST INFORMATION REPORT (FIR) AGAINST THE CANDIDATE FOUND CHEATING BY USING MOBILE PHONE IN WRITTEN EXAMINATION FOR RECRUITMENT TO THE POST OF CT(TRADESMAN) IN BSF

Sir,

It is to inform that 195 Bn BSF was assigned the responsibility to conduct the written examination for recruitment to the post of CT(TM) in BSF on 04.12.2022 at Siliguri Girls' High School in 2nd shift from 1400 hrs to 1600 hrs.

2. On 04.12.2022, at about 1500 hrs, one candidate namely Jhuna Singh S/o Surendra Singh (Roll No. 0705000046), resident of Village – Paliya, PS – Rajpur, Distrcit – Buxar, (Bihar) Pin – 802114 who was appearing in the said examination was noticed talking to someone in a low voice by invigilators HC Sonaram of 195 Bn BSF and Smt Konika Chatterjee. Thorough checking of the candidate was carried out by HC Sonaram and he was found hiding a small keypad mobile phone in his left armpit. On checking the call details in his mobile phone, it was found that he was talking on mobile phone no. 06206291613.

3. On this, he was immediately detained and matter was informed to board members' by HC Sonaram. The details of the mobile phone and other belongings found in his possession are as under :-

5. In view of the above you are requested to lodge a FIR against the said candidate and action to be taken as per the law of land in this regard accordingly.
