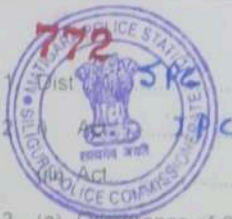

Sir,

In producing herewith 4 (Four) arrested accused persons named (1) Jagadish Barman (24) S/O Sri Hemanta Barman of Dhonsorajote (Near Prymari School), PO Ranidanga, PS Bagdogra, Darjeeling (2) Ranjan Das @ Scientist (27 yrs), S/O Lt Badal Das of Thiknikata (Behind Amit Agarwal Bhaban), PO Sushruta Nagar, PS Matigara, Darjeeling (3) Rupan Saha (27) S/O Sri Gopal Saha of Thiknikata (Near Nilkantha Lab), PO Sushrutnagar, PS Matigara, Darjeeling and (4) Palash Barman (24) S/O Sri Pradip Barman of Kawakhari Medical More (Near Laska Bridge), PO Sushruta Nagar, PS Matigara, Darjeeling along with seized articles i.e (i) one knife measuring 12" including wooden handle wrapped recovered from the possession of Jagadish Barman (ii) one iron rod measuring approx 24" recovered from the possession of Ranjan Das @ Scientist (iii) One iron rod measuring approx 25 inch pointed one end and one torch light recovered from the possession of Rupan Saha and (iv) one sharp cutting weapon (Daw) recovered from the possession of Palash Barman S/O Sri Pradip Barman under proper seizure list.

I, SI Arindam Banerjee of NBMC OP under Matigara PS/ SPC do here by lodged this written complaint against the above noted arrested persons to the effect that today on 06.11.22 at 00:05 hrs I received secret source information that 10/11 persons have been assembled beside Balason River Bank near Neem Tola ghat to commit dacoity at the locality. Immediately informed the tip of information to O/C NBMC OP and as per his kind direction I diarized the fact in GD book vide NBMC OP GDE No-135 dated 06/11/22 and 00:15 hrs myself along with ASI Prem Bhakta Mallick, ASI Krishnendu Roy, C/1071 Sumit Sherpa, CV-158 Partha Sarkar left for Balason River Bank near Neem Tola ghat to verify the veracity of the information. This refers NBMC OP GDE No-136 dated 06/11/22 and MCC No-1497/22 dated 06/11/22. At about 00:25 hrs I along with Police party arrived at the spot i.e Balason River Bank and after keeping our vehicle at a distant place we proceeded towards Balason River Bank near Neem Tola ghat on foot and being indicated by the source found from the considerable distance that a gang of 10/11 persons were assembled beside Balason River Bank near Neem Tola ghat and they were whispering in very low voice. Accordingly, we cordoned the place properly and approach towards them. But seeing the presence of police party, they scattered in multi direction and started fleeing away but after a hot chase we manage to apprehended 03 (Three) persons and others were fled away from the spot. On interrogation, the apprehended persons disclosed their name & address as noted above, and started giving incoherent statement regarding their presence/gathering in the same place also. On further grilling they stated that, they along with 7/8 persons were assembled there in preparation to commit dacoity. Accordingly, I managed to call two independent witnesses on the spot and on being search in presence of the independent witnesses from the apprehended persons recovered (i) one knife measuring 12" including wooden handle wrapped recovered from the possession of Jagadish Barman (ii) one iron rod measuring approx 24" recovered from the possession of Ranjan Das @ Scientist (iii) One iron rod measuring approx 25 inch pointed one end and one torch light recovered from the possession of Rupan Saha and (iv) one sharp cutting weapon (Daw) recovered from the possession of Palash Barman S/O Sri Pradip Barman. Accordingly, I seized the above noted recovered articles as per seizure list in presence of witnesses and duly signed by them in between 01:05 hrs to 01:30 hrs and I arrested them U/S 41 Cr.P.C. after explaining the charges against them.

Under the above fact and circumstances I pray that a specific case may kindly be started against (1) Jagadish Barman S/O Sri Hemanta Barman (2) Ranjan Das @ Scientist S/O Lt Badal Das and (3) Rupan Saha S/O Sri Gopal Saha, (4) Palash Barman S/O Sri Pradip Barman and others under proper Section of law.
