1. One (01) 4.5 mm. Pistol, iron made having length about 25 cm. with body, trigger, firing pin, barrel and fibre-fitted butt having marked with "COLT GOVERNMENT 1911 A1<sup>TM</sup>." and in opposite side marked as "UMAREX, Made in Germany having No. F124747165, packed, labelled & sealed as Exhibit –A.

2. One (01) white colour Four wheeler styled as Volkswagen Polo having No. WB-02-AC/4404 which is covered with black film all over the window glasses & back shield.

I, SI. Sandip Dutta, O/C, Ambari-Falakata Out Post, Ps-NJP, SPC, do hereby submit this written complaint against the above noted accused persons to the effect that, today, i.e. on 01.12.2022 at about 16.05 hrs received secret source information that two persons are coming in a small vehicle from Siliguri side towards Gajoldoba with an illegal fire-arms carried by them. Accordingly, I diarised the same in OP's General Diary Book vide GDE No. 27 dt. 01.12.2022 and conveyed the same to O/C, NJP PS, SPC. Therefore myself along with mobile van officer SI. Rakesh Debnath, C/505 Tapash Dutta & C/ 1180 Sushen Roy left for Nawapara More to verify the veracity of the information. At about 16.45 hrs we have reached at Nawapara More Traffic point and inform SI. Budhdha Tamang, O/C, Canal More Traffic Out Post, SPC about the information and request him to accompany with us. We have also request two independent witnesses named (i) Abhijit Majumdar S/o Lt. Ashim Majumdar Of Ambari-Falakata, P.O-Kamarvita, P.S-NJP, Dist-Jalpaiguri & (ii) Tarzan Roy, s/o – Narma Roy of 9 No Colony, PO – Kamarvita, PS - NJP, Dist - Jalpaiguri to accompany with us during search & seizure and both of them are agreed to do. Accordingly, we along with SI. Budhdha Tamang keeps sharp vigil over the flow of traffic movement and searching for the said vehicle. After some times at around 18.35 hrs on being identified by the source we have intercepted one suspected white colour four wheeler, styled as 'Volkswagen Polo' having No. WB-02-AC/4404 which is covered with black film all over the window glasses & back shield. Therefore, we knocked the window of this car and asked them open the door but they did not open the door. In the mean time seeing the said car, four persons who were standing at Nawapara More road side, came forward towards the vehicle and asked the on board person of the car by their names to open the door. Therefore, the driver of the car opened the door. I, then apprehended the two persons who were sitting inside the car. During interrogation it could be learnt that the four persons who were standing at Nawapara More road side namely (i) Prithviraj Chouhan (17) S/o Jay Prakash Chowhan@Himmat Of Champasari, W/No. 46, PS-Pradhan Nagara, Dist-Darjeeling, (ii) Aditya Singh (18) S/o Anil Kumar Singh Of Daulatpur, Dalkhola, PS-Dalkhola, Dist-Uttar Dinajpur, (iii) Om Bhagat (17) S/o Binod Bhagat Of Dalkhola College More, PS-Dalkhola, Dist-Uttar Dinajpur & (iv) Prayash Gattani (16) S/o Lt. Hanuman Das Gattani Of Iskcon mandir Road, W/No. 41, PS-Bhaktinagar, Dist-Jalpaifuri are friends of the passengers of this car and they are waiting there to join their said friends in this car for Gajoldoba. Therefore, we shared them the information in hand and asked to be cooperate during search and searched the vehicle in presence of above noted two independent witnesses and recovered One (01) 4,5 mm. Pistol, iron made having length about 25 cm. with body, trigger, firing pin, barrel and fibre-fitted butt having marked with "COLT GOVERNMENT 1911 A1TM." and in opposite side marked as "UMAREX, Made in Germany having No. F124747165 which was kept hiding in the front dashboard of this car. On interrogation the driver &

co-driver of that car namely (i) Akash Dey (24) S/o Tanmay Dey Of Deshbandhupara, P.O+PS-Dalkhola, Dist- Uttar Dinajpur and (ii) Sher Ali (20) S/o Samser Ali Of Uttar Dalkhola, Sharat Pally, PS-Dalkhola, Dist-Uttar Dinajpur became very nervous and did not give any satisfactory reason for keeping & carrying the said arms in their car neither they have able to produce any license against the said arms

Accordingly, I seized it under proper seizure list, duly signed by the witnesses and accused person and packed, labelled, & sealed the arms as Exhibit-A on the spot. The seizure & label was made in between 19.15 Hrs to 19.35 Hrs. dated 01.12.2022. Then, I arrested them after observing all formalities and issued memo of arrest.

Hence, I pray before you that a specific case may kindly be initiated against the above noted accused persons namely (i) Akash Dey (24) S/o Tanmay Dey Of Deshbandhupara, P.O+PS-Dalkhola, Dist-Uttar Dinajpur and (ii) Sher Ali (20) S/o Samser Ali Of Uttar Dalkhola, Sharat Pally, PS-Dalkhola, Dist-Uttar Dinajpur under proper section of law and to cause its investigation.
