With due respect, I am producing herewith the arrested accused persons namely (i) Raja Mallick (21) S/O Lt. Shreelal Mallick of Bhola More , PS- New Jalpaiguri, Dist.- Jalpaiguri (ii) Firoj Alam (28) S/O Lt. Injamul Haque of Rup Chandra Gachh, PS- New Jalpaiguri, Dist.- Jalpaiguri (iii) Sahid Alam (22) S/O Md. Soleman of Fulbari, Amaidighi, PS- New Jalpaiguri, Dist.- Jalpaiguri (iv) Md. Debaru (29) S/O Lt. Md. Nazimuddin of Goatmabari, P.S- NJP, Dist.- Jalpaiguri and the following articles under seizure :-

1. One Bhojali & One Blunt Iron Rod from the possession of accused Raja Mallick (21) S/O Lt. Shreelal Mallick of Bhola More , PS- New Jalpaiguri, Dist.- Jalpaiguri

I, SI Newton Biswas of NJP PS, Siliguri Police Commissionerate beg to state that on 03.12.2022 at 02.25 Hrs I received a secret source information that a gang of miscreants come to below Kashmir Colony More, under PS- NJP, Dist.- Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Gate Bazar, Accordingly, I informed the fact to you as well as Asstt Commissioner of Police, East -II, SPC and diarized the fact in General diary vide NJP PS GDE No 81 dated 03.12.2022. As per kind order and direction of my superior officer myself along with VP/13 Jamirul Islam, VP/08 Laxman Roy and CV/306 Bisawajit Roy, CV/116 Rohit Kr Mahato and CV/824 Niru Yadav left for Kashmir Colony More, under New Jalpaiguri PS, Siliguri Police Commissionerate to work out the information in hand. I also informed the fact to night RT Van officer of New Jalpaiguri PS, Siliguri Police Commissionerate and directed him to come to Kashmir Colony More to accompany with us during Raid. At about 0305 hrs on 03.11.2022 we arrived at Kashmir Colony more under New Jalpaiguri PS. After a few time night RT van officer ASI Pranab Majumdar of New Jalpaiguri PS, SPC along with force came to Kashmir Colony More and accompany with us. At about 03.15 hrs we found that 10/11 persons assembled in a dark place at Kashmir Colony More and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we the police party managed to apprehended 04 (Four) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. On search of the apprehended accused persons I found (i) One Bhojali & One Blunt Iron Rod from the possession of accused Raja Mallick (21) S/O Lt. Shreelal Mallick of Bhola More , PS- New Jalpaiguri, Dist.- Jalpaiguri (ii) One sharp cutting Sabol from the possession of accused Firoj Alam (28) S/O Lt. Injamul Haque of Rup Chandra Gachh, PS- New Jalpaiguri, Dist.- Jalpaiguri (iii) One Iron made sabol, One Torch Light from the possession of accused Sahid Alam (22) S/O Md. Soleman of Fulbari, Amaidighi, PS- New Jalpaiguri, Dist.- Jalpaiguri (iv) One Iron made Hasua, Screw Driver from the possession of Md. Debaru (29) S/O Lt. Md. Nazimuddin of Goatmabari, P.S- NJP, Dist.- Jalpaiguri.

During further interrogation they admitted their guilt and disclosed that they are assembled at below ashmir Colony More under New Jalpaiguri PS, Dist.- Jalpaiguri and making preparation for committing offence at Gate Bazar area under New Jalpaiguri PS. Accordingly, I seized the above noted weapon of offence under proper seizure list and arrested the above noted 04 (Four) accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to NJP PS. The search seizure made in between 0335 hrs to 0415 hrs on 03.12.2022.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper sanction of law may kindly be started against the arrested accused persons namely (i) Raja Mallick (21) S/O Shreelal Mallick of Bhola More, PS- New Jalpaiguri, Dist.- Jalpaiguri (ii) Firoj Alam (28) S/O Lt. Injamul Haque of Rup-Chandra Gachh, PS- New Jalpaiguri, Dist.- Jalpaiguri (iii) Sahid Alam (22) S/O Md. Soleman of Hatmabari, P.S- NJP, Dist.- Jalpaiguri (iv) Md. Debaru (29) S/O Lt. Md. Nazimuddin of Hatmabari, P.S- NJP, Dist.- Jalpaiguri and others and arrange for its investigation.
