As per kind order and direction of my superior officer myself along with VP/13 Jamirul Islam, VP/08 Laxman Roy and CV/306 Bisawajit Roy, CV/116 Rohit Kr Mahato and CV/824 Niru Yadav left for Kashmir Colony More, under New Jalpaiguri PS, Siliguri Police Commissionerate to work out the information in hand. I also informed the fact to night RT Van officer of New Jalpaiguri PS, Siliguri Police Commissionerate and directed him to come to Kashmir Colony More to accompany with us during Raid. At about 0305 hrs on 03.11.2022 we arrived at Kashmir Colony more under New Jalpaiguri PS. After a few time night RT van officer ASI Pranab Majumdar of New Jalpaiguri PS, SPC along with force came to Kashmir Colony More and accompany with us.
