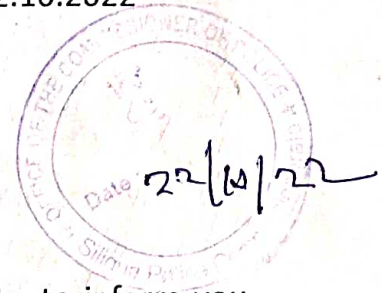

Respected Sir,

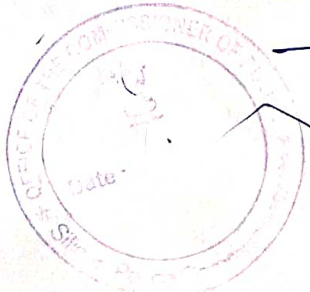
With due respect I the undersigned would like to inform you that on 19.10.2022 at about 10:10 a.m. in the morning I was going to DPS school, Dagapur, Siliguri with my wife by a motorcycle being Registration No. WB 74 R 3723 for admission of my near relative in the said school. On the way at Siliguri Junction Traffic more I stopped my motorcycle due to traffic signal and I was waiting for the green signal mean while one four wheeler (car) dashed me from back and due to such rash and negligent driving and such sudden dash, my wife sustained injury on her back and I also became disbalanced but somehow I managed to save me and the said motorcycle from falling and thereafter I asked the said driver of the vehicle why he was driving negligently and some hot alteration was took place between us and he misbehaved with me instead of tendering the apology for his rash and negligent driving and moreover the said person also misbehaved very rudely with my wife by abusing filthy languages in the mean time said person introduced himself as a police personnel and I also noticed that a plate was affixed in front of his car and written there "Police" and realizing that he is a police personnel, I apologized repeatedly by clubbing my hands towards him to give him the respect as a police but he did not pay any heed to that and he threatened me and my wife by saying that he will give us a remarkable lesson.

I would like to further inform you that he called the police personnel from Pradhan Nagar Police Station from his mobile and as per his direction I was brought to Pradhan Nagar police station by a police van at about 11:20 a.m. and I was forcibly pushed to the police lockup for whole day and I came to know there, said person is an Assistant Sub-Inspector of West Bengal Police and now he posted in the office of Assistant Commissioner of Police (East).

I would like to further inform you that after detaining me in the lockup for whole day, the O.C. of Pradhan Nagar Police Station came to his chamber at about 9'0 clock and I narrated him regarding the entire facts and I also requested him to see the video footage of the CC camera of the said traffic point of that relevant time regarding the true facts but the O.C. Pradhan Nagar Police Station requested me to settle the matter with him as because the said person is a police personnel and on his request myself being a layman gave the consent regarding the said settlement but I found that on the basis of a false complaint as made by the said person namely Kanak Das, S/o. Late Kartick Chandra Das, of Netaji Pally, Shivmandir, P.O. Kadamtala, P.S. Matigara, Dist. Darjeeling a case has been registered against me being Pradhan Nagar P.S. Case No. 845/2022 dated 19.10.2022, U/S – 341/325/506 of I.P.C. and at about 11:20 p.m. at night one SI Satish Ruchel asked me to put my signature in a document and after obtaining my signature I was released from there.

I would like to further inform you that yesterday i.e. on 21.10.2022 I got the bail from the Ld. Court at Siliguri and through my lawyer I came to know that the complaint was registered on 19.10.2022 at about 18:15 hrs but the incident was took place on 19.10.2022 at about 10:10 hrs in the morning and I was brought to police station at about 11:20 hrs in the morning and since then I was illegally confined and detained in the police lockup without any allegations or complaint.

I would like to further inform you that said Mr. Kanak Das being a police personnel has misused his official capacity and first he dashed me by his car due to rash and negligent driving and thereafter he influenced the I.C. and O.C. of Pradhan Nagar Police Station to confine me in the police lockup for more or less 12 hrs without any complaint and allegation and moreover said Mr. Kanak Das misbehaved with me and my wife in the public place and also in front of O.C. Pradhan Nagar Police Station and lodged the said false complaint to harass me and I am also very surprised that the I.C. and O.C. of Pradhan Nagar Police Station knowing the truth of the said incident, they saved their colleague instead of taking the proper action against him and I have been falsely implicated in the said criminal case thus Mr. Kanak Das under his influence the I.C. and O.C. of Pradhan

Nagar police station they all have misused their official capacity and broke the law most illegally for their ego and harassed me.

Under the above circumstance I would like to request you to investigate the matter and do needful for the ends of justice.

And for this act of kindness I will be much obliged to you.
