Respected Sir,

I, SRI TATUN GUHA , Son of Late Manindra Kumar Guha, aged about 66 years, Hindu by religion, business by occupation, resident of College Para, Silliguri, Post Office and Police Station: Silliguri, Dist.- Darjeeling, in the State of West Bengal, Pin – 734001, beg to state as follows:

- 1) That I am the sole and absolute owner of total land measuring 2.07 acres, recorded in L.R. Khatian No. 2096 comprised in and forming part of L.R. Plot Nos. 379 (measuring 0.11 acre), 381 (measuring 0.01 acre), 382 (measuring 0.89 acre) and 383 (measuring 1.06 acres) within Mouza- Kalkut, J.L. No.- 44, Touzi No. 91, Pargana – Patharghata, Police Station – Pradhan Nagar, District - Darjeeling.
- 2) That on 12/09/2022 at about 11:30 A.M., while I visited my above noted land for construction a boundary by fencing the on said land by concrete poles and barbed wire, (1) Sri Kumar Khaswas, S/o – Not Known, (2) Smt. Srijana Chhetri, W/o – Sri Kumar Khawas, (3) Sri Bacha Khawas, S/o – Not Known, (4) Sri Raj Kumar Thakuri, S/o – Sri Sudam Chandra Thakuri, (5) Sri Vikrant Subba (Limbu), S/o – Sri Chandra Bahadur Thakuri, (6) Sri Lalit Roy, S/o – Uttam Roy, (7) Smt. Aradhana Roy, W/o – Sri Lalit Roy and (8) Sri Dhrubo Pradhan, S/o – Not Known, all are residents of Near Freshia Apartment, Prasanti Nagar, P.O. & P.S. – Pradhan Nagar, District – Darjeeling, PIN - 734003 along with some hooligans and miscreants came to the above noted land with an intent to construct a short cut road on the middle portion said land to the houses of the above named persons which are situated behind my said land, thereupon threatened me with dire consequences and tried to evict me from my above noted land illegally by applying brutal force and coercion and on my protest, the above named persons loudly expressed their intention to construct the illegal short cut road and tried to encroach the said land aiding to brutal coercion.
- 3) That again on 18/09/2022 at about 10:00 A.M., the above named persons accompanied by some hooligans and miscreants came to my said land and tried to dispossess me there from and threatened me stating inter-alia that they will illegally and forcibly construct the short cut road on the middle portion of the said land and no one on earth can prevent them from for doing such construction on the my above mentioned land.
- 4) That finding no other alternative I filed a suit before the Ld. Civil Judge, Junior Division, Silliguri vide Title Suit No. 285 of 2022 and on 16/11/2022 after hearing Ld. Court was pleased to pass the following order, ".....That the instant prayer of ad interim injunction as prayed by the plaintiff is hereby considered and allowed. The principal defendants are hereby restrained from entering into the suit property or any part thereof and also from creating any sort of disturbance in peaceful possession of the plaintiff over the suit property till **16/12/2022**".

- 5) That today at about 12 P.M., when I visited my above noted land for construction of brick-built eastern side boundary, again (1) Sri Kumar Khaswas, S/o – Not Known, (2) Smt. Srijana Chhetri, W/o – Sri Kumar Khawas, (3) Sri Bacha Khawas, S/o – Not Known, (4) Sri Raj Kumar Thakuri, S/o – Sri Sudam Chandra Thakuri, (5) Sri Vikrant Subba (Limbu), S/o – Sri Chandra Bahadur Thakuri, (6) Sri Lalit Roy, S/o – Uttam Roy, (7) Smt. Aradhana Roy, W/o – Sri Lalit Roy and (8) Sri Dhrubo Pradhan, S/o – Not Known, all are residents of Near Freshia Apartment, Prasanti Nagar, P.O. & P.S. – Pradhan Nagar, District – Darjeeling, PIN - 734003 along with some hooligans and miscreants came again to the above noted land and restrained me with an intent to construct said short cut road on the middle portion said land, thereupon threatened me with dire consequences and tried to evict me from my above noted land illegally by applying brutal force and coercion and disturbed my peaceful possession even after the order of the Ld. Court and on my protest, the above named persons along with their hooligans and miscreants left the place by threatening me that they will come again.

It is therefore requested to treat the present complaint as FIR and take immediate legal action against (1) Kumar Khaswas, S/o – Not Known, (2) Srijana Chhetri, W/o – Sri Kumar Khawas, (3) Bacha Khawas, S/o – Not Known, (4) Raj Kumar Thakuri, S/o – Sri Sudam Chandra Thakuri, (5) Vikrant Subba (Limbu), S/o – Sri Chandra Bahadur Thakuri, (6) Lalit Roy, S/o – Uttam Roy, (7) Aradhana Roy, W/o – Sri Lalit Roy and (8) Dhrubo Pradhan, S/o – Not Known, all are residents of Near Freshia Apartment, Prasanti Nagar, P.O. & P.S. – Pradhan Nagar, District – Darjeeling, PIN - 734003 along with their hooligans and miscreants for violating the order of the Ld. Court and also for their other illegal acts.
