Sir,

In producing herewith one accused person named Amit Roy(24) s/o- Kalipodo Roy Of Dhakin Plas, near Bonka Spoting Club, Ps. Pradhannagar, Dist- Darjeeling under arrest along with following articles under proper seizure.

- 1) 30(thirty) bottles of Himalayan KACHI 70 UP Country Spirit each bottle containing 300 ml, manufactured by Prakash Distillery & Chemical Co. (P) LTD. Bandrijote, Pradhannagar, Siliguri-734003, West Bengal, Out of which one has been taken as sample for examination.

I, ASI Ashit Singha of Pradhan Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Amit Roy(24) s/o- Kalipodo Roy Of Dhakin Plas, near Bonka Spoting Club, Ps. Pradhannagar, Dist- Darjeeling to the effect that today on 05.12.2022 at 19.30 hrs received a source information that one person is selling liquor in his shop situated at Dhakin Plas, near Mahananda river side, under Pradhan Nagar Police Station without any valid license. Accordingly I informed the matter to you and as per your kind direction I along with Constable 762 Mojibul Rahman, CV/128 Ajoy Kumar Sahani, CV 223 Swapan Chettri All of Pradhannagar Ps had been to Dhakin Plas, near Mahananda river side, under Pradhan Nagar Police Station to verify the veracity of the information. This refers to Pradhannagar P.S. GDE no.285, Dt. 05.12.22. On reaching there and as identified by the source found that one person was selling and storing illicit distilled liquor at his shop. Subsequently, I along with my force cordoned the shop and was able to detain the above noted person. Thereafter on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the shop. Further being searched the above noted seized articles were found in the said shop. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last few months for his illegal gain. Then I seized and labelled the above mentioned illegal illicit distilled liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named Amit Roy(24) s/o- Kalipodo Roy Of Dhakin Plas, near Bonka Spoting Club, Ps. Pradhannagar, Dist- Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 20:25 hrs to 21.15 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Amit Roy(24) s/o- Kalipodo Roy Of Dhakin Plas, near Bonka Spoting Club, Ps. Pradhannagar, Dist- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
