Sub: Written Complaint

Respected Sir/Madam,

I, **RITA DEVI**, wife of Sri Hari Shankar Prasad, Hindu by Religion, Indian by Nationality, Housewife by Occupation, resident of Sriwani Road, P.O. & P.S. Singtam, East Sikkim, would like to lodge a complaint stating the following facts:

1. That I am the owner in possession of land measuring 9 katha 2 Chhtak or 0.15 Acre appertaining to and forming part of Plot Number 525 recorded in Khatian 13 of Mouza – kalkut, P.S. Matigara (Now Pradhan Nagar) in the District – Darjeeling (morefully and particularly described in schedule herein below) by virtue of Deed of Sale being document no. 780 of the year 2000 registered in the office of A.D.S.R. Darjeeling and thereafter mutated my land in L.R. Khatian No. 1373 which is presently recorded in the my name.
2. That 01.12.2022 around 11 a.m., I got the information that some people namely Pradeep Mandal, S/o Prashanta Mandal and Sri Suraj Rai, S/o Kistish Rai along with other local land grabbers are trying to enter into the said land and these miscreants were also carrying construction material such as cement, stones with an intention to take the possession of the same.
3. That on getting the information I along with the other my relatives and friends immediately left my home and rushed to the land and restrained the miscreants. They are still trying to take forceful possession of the same.
4. That previously a written complaint was also lodged before you on 01.12.2022 and the miscreants remained low for few days but the said miscreants have again started to do illegal construction over the land.
5. That on 04.12.2022 when I visited the land the abovenamed miscreants and his associates threatened me with life using filthy and abusive language and claimed that they would take possession of land in any manner possible. They threatened me to leave the land within 15 minutes if not I have to face dire consequences.
6. That now the miscreants are getting desperate and are time and again blackmailing me and pressurizing me to either settle the matter with them by providing them Rs. 20,00,000/- of the land value as ransom or and on my denial are threatening me that they will soon take illegal possession of the land.

7. That the said miscreants are using muscle power from well known land grabbers in the area and are continuously threatening to take the illegal possession of the land. The said miscreants along with the local goons are often loitering around the land and have clearly instructed that if their demands are not fulfilled they will not hesitate to shed blood and will take the possession of land at all costs and that nobody can stop them from doing so.
8. That I am a resident of Singtam, Sikkim and it is difficult for me to travel from there or appoint someone to look after my land on daily basis. Taking advantage of the same the aforesaid persons in collusion with other have hatched this ploy with an intention to extort money from me and are now using illegal means and muscle power to achieve their motive. They are still trying to take forceful possession of the said land already they have attempted 2-3 times to do so.
9. That they are threatening me and pressuring me every day and I am in a dilemma that if nothing is done the miscreants might at any time take possession of the land with the goal to extort money and there is a huge threat to our lives.

In the above circumstances, I would like to request you to kindly take immediate and necessary action against the aforesaid persons for such type of illegal activities and to safeguard our land.
