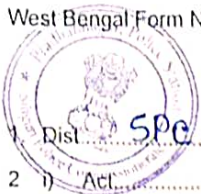

SUB: WRITTEN COMPLAINT AGAINST one NIMAI DAS (8967815118) DRIVER AND OWNER OF VEHICLE NUMBER WB/73/F/1517 for rash and negligent driving and hit and run.

Respected Sir,

With due respect and humble submission I, Amit Adhikary Son of Purna Kumar Adhikary resident of Salbari, Near Asha Kendra, Post Office Salbari and Police Station Pradhan Nagar Siliguri District Darjeeling would like to inform you an incident involving hit and run causing grievous hurt to my wife fracturing her leg and leaving her alone in middle of the road. The brief fact of the incident is as follows:

That on 22.11.2022 at around 4 pm- 4.30 pm when my wife Malina Kharel riding her Scooty bearing number WB/74/BD/2177 was returning from office to her way home in Salbari and in the crossing of Darjeeling more one vehicle bearing number WB/73/F/1517 came speeding from the City Centre Side without any siren and when the red light was on the side of the vehicle still without hesitating to stop or drive carefully it hit the Scooty making her injured grievously fracturing her leg and she was crying in pain when with the interception of the traffic police they stopped the said vehicle which was carrying a patient and requested that it was emergency and hence the police official left the vehicle keeping in mind the emergency situation and also admitted my wife in Medica North Bengal and informed me. When I reached the hospital I was shocked to see her situation as she was crying in pain then I shifted her to Dr. Mohpals Nursing Home where the situation was very serious and she had to operated immediately as her left leg tibia and fibula fractured and also hairline fracture in upper left leg bone so for better treatment I shifted her to Neotia Hospital where her surgery was carried on and a plate was inserted in her left leg in surgery.

That after such incident when I enquired the matter with the Police Officials gave me the details of the driver whom I contacted for any help from his side as I was devastated in that situation where I was shock to hear his reply stating that "ROAD MEI TO ACCIDENT HOTA REHTA HAI BHAIYA ACCHA HAI WHO MARI NAHI" and agitated when I said him that I will complain the matter to the Pradhan Nagar Police

Station he threatened me that he is the owner of ambulance and his union will help him to get the bail and press the matter as he knows influential people from his locality further he also threatened me that if I go to police or any authority he will always be in vehicle in roads and in future it will not only be fracture but also converted to accidental death quoting that accidental death is Bailable offence which made me astonished as how come an ambulance driver be so aware and again I thought that maybe he is habitual in these type of incidents and after hearing this I thought that there is no question of leaving these kind of negligent and legally irresponsible people free outside the society as of now my wife have just suffered leg fracture injury who might know that these people might also kill people in roads and term them as accidental death.

Therefore Sir, I request you to kindly take strict action against the person said NIMAI DAS whose fathers name is nor known only I know the mobile number which is given above and further file an appropriate case according to law and help me in getting justice through your esteemed office and also save innocent people, kids, old aged persons from such irresponsible drivers who does not have any respect for the life of other people in roads. Thanking You.
