Beshata, Dist. Cochinagar - Pincode no. 735101 would
like to inform you that on 06.12.2022, at about
01-30 PM, my husband Mihir K. Deb started towards
Raiganj by WBSTC BUS (Cochinagar - Kolkata). At about
7.30 P.M. on 06.12.22 I have got information through
Cochinagar P.S. that my husband has been admitted
at Siliguri District Hospital by Prastha Nagar Police,
Subsequently it has come to my knowledge through
Prastha Nagar Police that the co-passenger of my husband
gave him escort and after taking said escort my
husband got unconscious and the miscreants fled away
snatching his mobile, money bag having SBI ATM
card, Amtrak card, cash Rs. 8000/-, two golden earrings,
and one pair golden ear ring, bus ticket.

That on 07.12.22 at about 03.45 AM I along with
my relatives approached Siliguri Hospital and met with
my husband while he sleeping at Bed no. 29. A Male
Medical Head and talked with the on duty Sister to
know the present condition of my husband while
she asked me that you can release your husband.
Accordingly I, released my husband on my own risk.

Today I appear before you to lodge written
complaint to book the culprits and arrange to
across the states properly in accordance with
law.
