
- i) 11(Eleven) Plastic bottles of Himalayan gold , Country Spirit, 60* up each bottle containing 600 ML.

I ASI Tarun Kanti Ghosh of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused female person to the effect that today on 07.12.22 in course spl mobile van duty at PS area with force C/762 Mojibar Rahaman CV/242 Rakesh Mongar ,CV/645 Pankaj Gupta vide PDN PS GDE NO 408 dtd.07.12.22 at 19.45 hrs ,I received an information that the one person namely Biswanath Mahato is storing and selling liquor illegally in his Hotel at Dagapur near Lokenath Mandir ,Styles as "Shib Hotel" under Pradhannagar PS .Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and as pointed by the source we apprehended the above noted person and search his shop recovered above noted articles , On demand apprehended person failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 20.05 hrs to 20.25 hrs and I arrested him.


Therefore, I request you to start a specific case under proper section of law against the arrested accused person namely Biswanath Mahato (24) s/O Sri Ram Nihora Mahato of Dagapur, near Lokenath mandir, P.S-Pradhannagar , Dist. Darjeeling and arrange for its investigation.
