Situated at Thokkar, Kachra market near old Shiv mandir I along with my Bhavi (Sushmita Sahani) went there my husband along with my - in-laws didn't let me into the house and when I forcefully entered the house I saw a lady namely - muni Singh was lying in the bedroom, when I asked her about who is she she said that she is my husband's second wife, I asked my husband about this then everyone present in the house namely (Laxmi Sahani (Narad), Surran Sahani (Narad), Sagina Sahani (mother-in-law) Paro Sahani (sister-in-law) Surran Sahani (Jethani), Munna Sahani (chacha), and wife of munna Sahani, they started
