Sir,

Suman Sengupta, Son of Ashoke Sengupta, D.E & SM Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India do hereby lodge this complaint against Sri Sushil Sha, (Ph- 7001265106), Son of Not Known, resident of Lower Bhanunagar, Opposite Modak Sweets, near Shivmandir Siliguri, Ward No-43, SMC, Dist- Jalpaiguri, West Bengal 734001, P.S Bhaktinagar.

On 07.12.2022 at around 1818 hrs Sri Suhil Sha along with an unidentified person (Photos Attached) entered the office of Power House CCC, WBSEDCL, 2nd Mile, Sevoke Road, Opp Cosmos Mall, and started an argument with Bidyut Sarkar Reader working under power house ccc and Sri Debashish Paul Billing Supervisor Power House CCC regarding a phone call that Sri Bidyut Sarkar had called him regarding his address. Earlier Sri Bidyut has called him up at around 1612 hrs to enquire about his address for meter reading and billing purpose, later at around 1754 hrs Sri Sushil Sha called Sri Bidyut Sarkar and started hurling verbal abuse as to why he had called him up, Sri Sushil Sarkar told him to come to office and talk with office personnel, Sri Suhsil told him to wait in Power House ccc as he would come and see who had called him to ask about his address. Later Sri Sushil Sha along with his associate enter the office and started an argument with him and the reading supervisor present in office, this argument later turn violent in a verbal manner and Sri Sushil started abusing Sri Bidyut Sarkar and Sri Debashish Paul, Reading supervisor, and when the other office members (Sri Jotiska Sengupta (Sr O.E), Md Azharuddin (Jr Engineer GR-II), Sri Ujjal Roy (Agency Worker), undersigned and others) present in the office objected to his manner of speech, he and his associate threatened us of dire consequences, if anyone from or associated with WBSEDCL attempted to take reading in his house or check his energy meter for that matter. Immediately Bhaktinagar P.S was intimated and within minutes a PCR van arrived at our office premises. The police officer present in the PCR van came to our office and stopped Sri Suhsil Sha and his associate from obstructing our office work. Sri Sushil Sha admitted openly in front of the police personnel as well as all the members present in the office that he was intoxicated. Later Sri Bidyut Sarkar submitted an application wherein he stated that he is scared to work in the area where Sri Suhil Sha resides, unless proper action regarding his safety is taken.

Thus you are requested to kindly initiate an investigation against Sri Sushil Sha for this deliberate attempt of hooliganism and creating chaos in an intoxicated state in a manner to obstruct Govt workers from delivering proper public service and hamper the normal activity of the office by verbally abusing and threatening WBSEDCL Workers and employees and take necessary action against him.
