Sir,

In producing herewith one accused person namely 1.Md. Sajid (30 Years) S/O- Lt. Atik Ahamed of Dipnagar, Dehradun, State-Uttarakhand A/P- Hill view Restaurant, Toribari, P.S- Bhaktinagar, Dist- Jalpaiguri along with following articles under proper seizure list-

- 1] 12 (Twelve) bottles of Calsberg Premium Elephant Strong beer (each bottle containing 650 ml)
- 2] 12 (Twelve) bottles of Kingfisher Strong beer (each bottle containing 650 ml)

I, SI Rantu Haldar of Bhaktinagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one namely 1.Md. Sajid (30 Years) to the effect that today on 08/12/2022 at 14.25 hrs while performing evening patrolling duty, received a source information that one person namely 1.Md. Sajid (30 Years) S/O- Lt. Atik Ahamed of Dipnagar, Dehradun, State-Uttarakhand A/P- Hill view Restaurant, Toribari, P.S- Bhaktinagar, Dist- Jalpaiguri is selling liquor in his shop situated at Toribari under Bhaktinagar PS, without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction myself along with force- C/915 Chandra Prakash Adhikari, C/1431 Dilip Barman, CVF /-935 Biplab Roy had been to Toribari under Bhaktinagar PS to verify the veracity of the information. On reaching there and as identified by the source it found that one person was selling and storing liquor at his shop. Subsequently, I along with my force cordoned the shop and was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of the shop. Further being searched the above noted seized articles were found in his shop. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further he stated that he is involved in selling and possessing of liquor without any valid license for last 04(Four) months for his illegal gain. Then I seized the above mentioned liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person namely 1.Md. Sajid (30 Years) S/O- Lt. Atik Ahamed of Dipnagar, Dehradun, State-Uttarakhand A/P- Hill view Restaurant, Toribari, P.S- Bhaktinagar, Dist- Jalpaiguri after observing all sorts of formalities at the spot. The whole process of seizure has been made in between 15.35 hrs to 16.05 hrs at the spot. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against 1.Md. Sajid (30 Years) S/O- Lt. Atik Ahamed of Dipnagar, Dehradun, State-Uttarakhand A/P- Hill view Restaurant, Toribari, P.S- Bhaktinagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
