Sir,

In producing herewith two (02) lady accused namely (i) Tuk Tuki Paswan(21),W/O- Suresh Paswan of Katihar Bazar, Katihar Station, ps- Katihar, Dist- Katihar, State- Bihar with her lap(F/one month) (not verified) and (ii) Titli Paswan (20), W/O-Raju Paswan of Katihar Bazar, Katihar Station, PS- Katihar, Dist- Katihar, State- Bihar(not verified) under arrest along with following articles under proper seizure;

1. 20 (twenty) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 12 liters, value Rs 2400/- .kept in a nylon bag and marked as "Exhibit-A" out of which 01 (One) bottle taken as sample and marked as "Exhibit -A-1" [The article was found under exclusive and conscious possession of lady accused Tuk Tuki Paswan.
2. 20 (twenty) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 12 liters, value Rs 2400/- kept in a nylon bag and marked as "Exhibit-B" out of which 01 (One) bottle taken as sample and marked as "Exhibit -B-1" [The article was found under exclusive and conscious possession of lady accused Titli Paswan.

I, SI Goutam Tamang of Siliguri Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against the above noted (i) Tuk Tuki Paswan. and (ii) Titli Paswan to the effect that today on 07.12.2022 at about 08.35 hrs during my mobile van duty, received a source information that two lady are standing at Town Station More with huge quantity of liquor under their possession without any valid license with a view to transport the same to Bihar through Bihar bound vehicle. Accordingly shared the information with I/C Siliguri PS over telephone and I also requested to him for sending lady officer/force for the purpose. Subsequently, I had been to Town Station More to verify the veracity of the information. After some time LC/1282 Swastika Sharma and LCV/176 Partbati Barman both of Siliguri PS, SPC arrived at Town Station More Siliguri. On reaching at Town Station More and being pointed by my reliable source, we apprehended two ladies and from their exclusive and conscious possession the above note articles could be found of which they failed to produce any valid documents. Subsequently, being interrogated, both the apprehended lady after disclosing their identity as above further revealed that they have procured the above noted 60 UP Country Spirit clandestinely for transporting and selling the same to Bihar to their designed customer at high rate for their wrongful gain and they don't have any valid license for the same. Accordingly, I seized and labeled the above mentioned articles at the spot under proper seizure list in presence of witnesses and also arrested the above mentioned lady namely (i) Tuk Tuki Paswan. and (ii) Titli Paswan with the help of accompanied lady force observing all sorts of formalities. The whole process of seizure has been made in between 09.15 hrs to 09.45 hrs at the spot.

Therefore, I pray before your good self that a specific case may kindly be initiated against (i) Tuk Tuki Paswan(21),W/O- Suresh Paswan of Katihar Bazar, Katihar Station, PS- Katihar, Dist- Katihar, State- Bihar with her lap(F/one month) (not verified) and (ii) Titli Paswan (20), W/O-Raju Paswan of Katihar Bazar, Katihar Station, PS- Katihar, Dist- Katihar, State- Bihar(not verified) under proper section of law and arrange for its investigation.
