In producing herewith arrested accused namely (i) Raju Mandal S/o- Lt. Ramesh Mandal of DurgaDas Colony, W/no- 20, PS- Siliguri, Dist- Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz:

i) Twenty (20) Bottles Sealed Himalayan Gold premium 60 Up Country Spirit each containing 600 ML each labeled as Himalayan Endeavour PVT Ltd. Siliguri, West Bengal @ Rs 120 each (Amounting of Rs. 120/-*20=Rs 2400/-), in which one sealed bottle has taken from mother packet box as sample under proper seizure list, labeling and memo of arrest.

I, SI Basudeb Guha of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the accused person namely Raju Mandal S/o- Lt. Ramesh Mandal of DurgaDas Colony, W/no- 20, PS- Siliguri, Dist- Darjeeling to the effect that on 07.12.22 during my performing PC mobile Van duty when we reached at Bagrakote Bus Stand area at that time found one person carrying huge quantity of illicit liquor on a nylon bag. Accordingly we apprehended him and on interrogation he stated that the above noted illicit liquor to sell the same at the shop of Kamal Lama situated at Bagrakote.

On further interrogation he stated that he used to sale the 60 up country Spirit to the owners at different areas without any valid documents as he violated the norms of Bengal Excise Act for selling the said Liquor without any valid License. On search twenty (20) Bottles Sealed Himalayan Gold premium 60 Up Country Spirit each containing 600 ML each labeled as Himalayan Endeavour PVT Ltd. Siliguri, West Bengal @ Rs 120 each (Amounting of Rs. 120/-*20=Rs 2400/-) in which one sealed bottle has taken from mother packet as sample as per seizure list which was kept concealed at nylon bag which he was carrying.. On being interrogation he could not produce any valid documents in respect of said liquor. He also stated that he is doing this Liquor business since long for his wrongful gain. Accordingly I seized the same in presence of witness duly signed by the witnesses. The seizure and label was made in between 18:45 hrs to 19:20 hrs. As such I arrested him U/S- 41 Cr.P.C after observing all legal formalities.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused lady namely Raju Mandal S/o- Lt. Ramesh Mandal of DurgaDas Colony, W/no- 20, PS- Siliguri, Dist- Darjeeling along with seized articles under proper section of law and arrange for its investigation.
