Respected Sir,

I Mitu Das, wife of Nirman Das, resident of "Priodarsini", Hari Sabha Road, New Milan Pally, Post Office: Siliguri Bazar, Police Station: Siliguri, District: Darjeeling, Pin Code: 734005, would like to register a complaint against Usha Ranjan Majumder s/o Aswanikumar Majumder, Subha Ranjan Majumder s/o Usha Ranjan Majumder and Debasmita Majumder w/o Subha Ranjan Majumder, all resident of Hari Sabha Road, New Milan Pally, Post Office: Siliguri Bazar, Police Station: Siliguri, District: Darjeeling, Pin Code: 734005 (beside the place of my residence) and would like to bring your attention to the below mentioned facts.

One Usha Ranjan Majumder had entered into a development agreement with one builder "Om Construction Agency" and had developed a residential apartment named "Priodarsini" at Hari Sabha Road, New Milan Pally, Post Office: Siliguri Bazar, Police Station: Siliguri, District: Darjeeling, Pin Code: 734005. My father-in-law Khokan Das and my mother-in-law Jolly Das had bought a residential flat at the said apartment from the said builder vide deed no. I-0402-00440/2022 registered at the office of ADSR Siliguri and all the payments was paid in full to the builder before the registration of the sale deed.

Usha Ranjan Majumder claims that he has not been paid by the builders and was not letting us enter into our own flat.

Last night at around 07:30pm, in presence of our close ones we had conducted a housewarming puja at the said residential flat. There were mostly ladies present in the puja including my in-laws. At that time my husband was not at home and was out working. The above-mentioned Usha Ranjan Majumder, Subha Ranjan Majumder and Debasmita Majumder ambushed into my house and started shouting using inappropriate slang languages and threatened us with dire consequences. They started to push us around using excess force and tried to take us out of the flat. Hearing all these commotions my neighbors had come to see what had happened.
