Sir,

In producing herewith two arrested accused person namely 1. Suresh Sahani (40) S/O- Mahabir Sahani of Prakash Nagar, W.No-43, P.S- Bhaktinagar, Dist-Jalpaiguri (Not Verified) 2. Kalu Paswan (35) S/O- Lt Ramatar Paswan of Prakashnagar, Sahani Busty W.No-43 P.S- Bhaktinagar, Dist-Jalpaiguri (Not Verified) along with two seized vehicle bearing no- WB- 76A 4625 (Tata Truck) & WB 73B 8109(Tata Truck) loaded with river bed materials each 100cft under proper seizure.

I, SI Sajal Roy of Bhaktinagar Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against two arrested accused person namely 1. Suresh Sahani (40) S/O- Lt Mahabir Sahani of Prakash Nagar, W.No-43, P.S- Bhaktinagar, Dist-Jalpaiguri (Not Verified), 2. Kalu Paswan (35) S/O- Lt Ramatar Paswan of Prakashnagar, Sahani Busty W.No-43 P.S- Bhaktinagar, Dist-Jalpaiguri (Not Verified) the driver of Seized vehicle bearing no- WB- 76A 4625 (Tata Truck) & WB 76A 8109 (Tata Truck) loaded with river bed materials approx 100cft to the effect that today on 09.12.2022 at 22.05 hrs received a specific source information that two vehicle bearing no- WB- 76A 4625 (Tata Truck) & WB 76A 8109 (Tata Truck) loaded with river bed materials had been coming from Military Ghat towards Bhanunagar under Bhaktinagar PS. Accordingly I informed the matter to the I/C PS and being directed by the I/C PS myself along with assisting force left PS to verify the veracity of source information. On the way towards Bhanunagar I detained two vehicle bearing no- WB- 76A 4625 (Tata Truck) & WB 76A 8109 (Tata Truck) loaded with river bed materials, at Bhanu nagar uner PS Bhaktinagar and also apprehended the driver of the said vehicle who on being asked disclosed their identity as 1. Suresh Sahani (40) S/O-Mahabir Sahani of Prakash Nagar, W.No-42, P.S- Bhaktinagar, Dist-Jalpaiguri. 2. Kalu Paswan (35) S/O- Lt Ramatar Paswan of Prakashnagar, Sahani Busty W.No-43 P.S- Bhaktinagar, Dist-Jalpaiguri (Not Verified) on demanded they failed to produce any valid documents/papers for carrying the river bed materials. On being further interrogation the driver of the vehicle bearing no- WB- 76A 4625 (Tata Truck) & WB 76A 8109 (Tata Truck) stated that they are involved in carrying of river bed materials by illegal means for their wrongful gain since last few months and procured the same fraudulently from somewhere. Accordingly I seized the vehicle bearing no- WB- 76A 4625 (Tata Truck) & WB 76A 8109 (Tata Truck) being loaded with river bed materials each 100cft and subsequently arrested the driver named 1.Suresh Sahani (40) 2. Kalu Paswan (35). The whole process of seizure and arrest was made in between 22.35 hrs to 22.55 hrs in presence of available witnesses.

Hence, I pray that a specific case may kindly be started against the drivers namely 1.Suresh Sahani (40) S/O-Mahabir Sahani of Prakash Nagar, W.No-42, P.S- Bhaktinagar, Dist-Jalpaiguri (Not Verified) 2. Kalu Paswan (35) S/O- Lt Ramatar Paswan of Prakashnagar, Sahani Busty W.No-43 P.S- Bhaktinagar, Dist-Jalpaiguri (Not Verified) and owners of the trucks under proper section of Law and arrange for its investigation.
