forcefully. An injunction has been extended till 7th
January, 2023 from Court of the Civil Judge (Tr. Div.),
Siliguri. My advocate Shri. Kaushik Das sent a
legal notice under Section 80 C.P.C. to the
panchayat of Matigara-II Gram panchayat and to
the Pradhan of mentioned Gram panchayat on
1st December, 2022 with all the supporting documents.

Despite of all these, today (8th Dec, 2022) they
have entered to my personal property and started
their construction work from morning.

I would request you to look into the matter and
do the need full.
