Dear Sir,

With due respect I, SMT. SITA MAHATO, W/O Sri Yogeshwar Mahato, resident of Near River Side, Mukta Mancha, Baghajatin Colony, P.O. & P.S. Pradhan Nagar, Dist- Darjeeling, would like to lodge this written complaint to the effect that some of my neighbors namely 1) Pinki Das, W/o Basu Das 2) Basu Das, S/o Unknown, 3) Purni Das, D/o unknown, 4) Biswajit Das & their associates are coming to our house since 02.12.2022 on regular basis and they regularly threatening me and my entire family with dire consequences without any just cause and reason. On 08.12.2022, at about 06:40 PM, the above mentioned persons were asking me and my family members regarding the whereabouts of my son namely Pawan Kr. Mahato and when I told them, that, I am unaware of his whereabouts, at this, the aforesaid persons became furious and forcefully criminally trespassed into my house and entered into my room as well as the room of my daughter in-law who is in her advance stage of pregnancy and the above mentioned persons started to damage the household articles without any cause and reason and when I raised my objection, the persons became more furious, and started to abuse me with filthy and slung languages which tantamount to modesty of a woman and also assaulted and molested me and they assaulted my husband who is an old man, also sustained bodily injuries on his personnel, the above mentioned persons tried to attack on my pregnant daughter in-law



but somehow I managed to lock the door and rescued her and when I started hue and cry, some of the local neighbors came at my house in order to rescue me from the hands of the above named culprits and seeing the said situation left the spot and at the time of leaving the spot they taken away Rs. 750/- cash which was kept underneath the mattress of my bed and they threatened me that they will not hesitate to ruin our life. Thereafter, I along with my husband with the help of the neighbor went to the Siliguri District Hospital in order to get my treatment for the injury caused by them and due to our injury and treatment purpose.

I, therefore, request you to register this complaint as FIR and please take necessary legal steps against the above mentioned persons and other miscreants as per the provisions of law and obliged thereby.
