Respected Sir,

I, **SRI RAJA KUMAR**, Son of Sri Satrugan Prasad Bhagat @ Yadav, resident of Madhepura, Ward no. 16, P.O., P.S. & District- Madhepura, Bihar, would like to inform you that on 07/12/2022 I came to Siliguri for my business purpose. Thereafter I boarded at the Hotel namely Gulma View, situated at Champasari, P.S. Pradhan Nagar, District- Darjeeling and West Bengal at about 9:30 P.M.

On 08/12/2022 my relative namely Arvind Kumar Prasad, Son of Raj Kishor Prasad, Resident of Deshbandhu Para, P.S.- Siliguri, District- Darjeeling, West Bengal, came to meet with me at the said Hotel. I came to know that some illegal activities with respect of girls are going on in the said hotel and thereafter I protested against the said illegal activities. Suddenly at about 10:30 p.m. the manager of the said Hotel, male staff namely Virat and one female staff came to my room and illegally started to demand money on the gun point from me and my relative namely Arvind Kumar Prasad, when we denied to fulfill their illegal demand and we protested against said illegal act, Virat and the manager started to assault us brutally by kicks and fists on our body and said Virat tried to kill me by chocking my neck. Due to their assault my spectacles amounting to Rs. 9,891/- was measurably damaged. Thereafter Virat and the manager of the said hotel on the gun point snatched a sum of Rs. 84,000/- (Eighty Four Thousand) from my bag, my purse containing a sum of Rs. 13,000/- (Thirteen Thousand), ATM Cards of ICICI Bank, HDFC Bank, Bank of India and my Aadhaar Card. Said Virat snatched my gold chain from my neck. Thereafter they threatened me not to complaint before any authority regarding said

matters, if I complaint regarding the said matter to any authority, they will kill me or involve in several false cases. They also damaged the motor cycle (bullet) vide no. WB-72-S-6525 of my relative. After some time I requested the manager of the said hotel to return my hard earn money, purse and gold chain but he denied to return the same. In the mean time the owner of the said hotel came in the hotel along with three persons and after knowing all the facts the owner of the hotel assured me that he will take proper steps to return my money, purse and gold chain certainly and requested not complaint regarding said incident. Thereafter I fled away from the said hotel to protect my life and my belongings are at the said hotel till now.

It is pertinent to mentioned here that one of the staffs of the said hotel namely Virat, having mobile no. 8436276788 is continuously threatening me over phone not to complaint before any authority regarding said matters if I complaint regarding the said matter to any authority, they will kill me or involve in several false cases. Sir due to several injuries on my body and for my mental agony, I unable to come at the P.S. till today. I am requesting you to take appropriate legal action against the above named persons and collect the CC. T.V. footage of the said hotel and also recover my belongings, hard earn money, purse and gold chain. For this act I shall ever remain grateful and remain obliged for the same.
