Sir,

With due respect I am producing herewith 01 (One) arrested accused person namely Oyzaed Ali Sheks (73) @ Oyzaed Ali Sheks s/o Lt. Hillal Ludin Sheks of Hyderpara, Meglal Roy Sarani, Ward No - 39, PS- Bhaktinagar, Dist- Jalpaiguri under arrest. The ground of arrest duly been communicated with him and the following articles under seizure :-

- (i) 01 (One) improvised small Fire arm (One shooter) measuring 29.60 cm in length including its 17.5 CM barrel with one trigger, striking hammer, striking pin in working condition Marked as Exhibit "A" and Loaded
- (ii) 01 (one) round live ammunition marked as Exhibit-"B".
- (iii) One Black Color FORCE Gorkha Vehicle bearing Registration No.- WB/74BL/5303.

I, SI Pradeep Dyal, of N.J.P. PS, SPC do hereby lodge this written complaint against the above noted arrested accused person to the effect that today i.e. on 05.12.2022 at about 1015 hrs I received secret source information that one Vehicle bearing Registration No- WB/74BL/5303 would be Coming at Shaktigarh under New Jalpaiguri PS, Siliguri Police Commissionerate with improvised fire arms. Accordingly, I Disrised the information in General diary vide NJP PS GDE No 188 dated 05.12.2022 and informed the fact to you as per kind order and direction myself along with ASI Sajal Das, VP/13 Jamirul Islam, VP/08 Laxman Roy, IC/794 Ranjit Roy and CV/306 Bisawajit Roy all of NJP PS, SPC left for Shaktigarh Road No.- 03, under PS-NJP, Dist- Jalpaiguri with investigation kit to work out the information in hand by Govt. vehicle. In the Mean time I called two independent witness namely (i) Buddha Dev Saha s/o Arun Saha of Suryasen Colony, Ward No -34, PS- New Jalpaiguri, Dist- Jalpaiguri and (ii) Sukamal Sen Gupta s/o Lt. Subir Sen Gupta of Shaktigarh, Road No- 03, PS- New Jalpaiguri, Dist- Jalpaiguri and requested them to be present as Independent witnesses during search and seizure if any. We reached at the spot i.e. Shaktigarh Road No.- 03, near pathagar Club, PS-New Jalpaiguri, Dist.- Jalpaiguri at about 1035 hrs on 05.12.2022 and as indicated by the source we found that Black Color FORCE Gorkha Vehicle bearing Registration No- WB/74BL/5303 is parked near Patha Ghar Club, Shaktigar Road No.- 03, PS-New Jalpaiguri, Dist- Jalpaiguri. Accordingly I intercept the FORCE Gorkha vehicle bearing Regsitratio No. WB/74BL/5303 and found that One person sitting left side of Driver seat weating for Someone inside the vehicle. Subsequently, we impart the information in hand to the person sitting inside the vehicle and request him to cooperate during whole process of search and seizure. On being asked he disclosed his name and address as noted above and in presence of independent witnesses, I searched the vehicle and after prolonged search, I recoverd one 01 (One) improvised small Fire arm (One shooter) measuring 29.60 cm in length including its 17.5 CM barrel with one trigger, striking hammer, striking pin in working condition loaded with 01 (one) round ammunition concealed below left seat of the driver. On being asked he failed to give any satisfactory reason for keeping & carrying the said arms in his Car neither he failed to produce any license or valid documents against the said arms.

Accordingly, I seized the recovered Improvised Fire arms after preparing proper seizure list, duly signed by the witnesses and accused person and packed, labelled & sealed the arms as Exhibit-A on the spot. The vehicle search & Seizure made in between 1115 hrs to 1215 hrs date: 05.12.2022, I arrested the accused person namely Oyzaed Ali Sheks (73) s/o Lt. Hillal Ludin Sheks of Hyderpara, Meglal Roy Sarani, Ward No - 39, PS-Bhaktinagar, Dist- Jalpaiguri after issuing proper Memo of arrest and observing all the guideline issued by Apex Court and also the ground of arrest has duly communicate to him.

Under the above noted facts and seizure of incriminating articles there is strong reason to believe that the said accused person namely Oyzaed Ali Sheks (73) @ Oyzaed Ali Sheks s/o Lt. Hillal Ludin Sheks of Hyderpara, Meglal Roy Sarani, Ward No - 39, PS- Bhaktinagar, Dist- Jalpaiguri is desperate and dangerous in nature as he was carrying the said fire arm and ammunition without any objective
