Sir,

With due respect, I Sri Nikhil Shah S/o Sri Pashupati Shah, resident of Jasodha Residency, Udham Singh Sarani, Haiderpara, P.O - Sevoke Road, P.S - Bhaktinagar, District - Jalpaiguri, would like to inform you that today at about 12.30 p.m my father returned from market at the aforesaid building complex and at that time one meeting of flat owners of Jasodha Residency was going on in the community hall, and my father as usual parked his motorcycle in the common area, in the mean time one Babulal Sharma S/o Late ~~Sharma~~ R. Sharma came out from the community hall and started abusing my father in filthy languages over the issue of his parking and threatened to set ablaze the motorcycle and when my father has raised his objection the said Babulal Sharma called his wife name not known, his son Atul Sharma, his brother Sanjay Sharma and some other persons who were present in the said community hall and have started assaulting him by fist and blows and the said Babul Lal Sharma has started assaulting my father with wooden stick was brought by his wife causing my father sustained serious blood injuries on his part and when my brother Sri Vivek Shah S/o Sri Pashupati Shah came to the place of occurrence after hearing the hue and cry of my father, he was also been mercilessly been assaulted by the above named persons and he also sustained serious injuries on his part with threatening that if my father dared to park his motorcycle in the common area, they will kill him. Due to their assault my father and brother sustained serious injuries and blood from nose and other part of their body has started oozing. The said Atul Sharma and Sanjay Sharma have torned the clothings of my father and snatched the Gold Chain of my father weighing about 20 grams and snatched the gold chain of my brother Vivek Shah weighing about 25 grams.

My father has been admitted to Siliguri Sadar Hospital and is fighting for his life and death and his condition is serious.

Be it mention here that one case of murder is pending against the above named persons and they have threatened that one murder case is going on, causing they have no fear of second murder.

So requesting you to investigate the matter and take necessary legal action against the above named persons for the interest of justice.
