Respected Sir,

With due respect, I, **SMT. GITA SARKAR**, Wife of Sri Niranjan Sarkar, Resident of D.L. Roy Sarani, Mahananda Para, Siliguri, P.O. & P.S. Siliguri, Dist. Darjeeling, would like to lodge this written complaint before your good office to the effect that I along with my husband Sri Niranjan Sarkar are the absolute joint owners of all that piece or parcel of land measuring 2 Kathas 4 Chhataks 23 Sq. Ft., situated at D.L. Roy Sarani, Mahananda Para, Siliguri, P.O. & P.S. Siliguri, Dist. Darjeeling and we have been occupying, possessing and enjoying the aforesaid land in our actual khas and physical possession, having right, title and interest therein.

Sir, since after occupying the aforesaid land in our actual khas and physical possession, the adjacent land owners namely **Smt. Rupashree Banerjee**, her son namely **Sri Subhadeep Banerjee**, her Son-In-Law namely **Sri Debabrata Dhali** and her married daughter **Smt. Ankita Dhali**, in conspiracy with some land grabbers and anti social persons, have been creating so many disturbance upon us for peaceful enjoyment of the aforesaid land and they have also tried to construct a boundary wall encroaching our aforesaid land and also the land of public common road illegally for their wrongful and illegal gain for which, we have made several complaints against them before your good office as well as before the authority in concern for proper remedy but the aforesaid persons are very influential in nature and even they did not hesitate to take the law in their hands in order to fulfill their wrongful and illegal gain.

Thereafter, in the month of January, 2021, the aforesaid persons again tried to capture our land by constructing the boundary wall encroaching our land including the land of the public common road and when we made protest and raised our voice against them, they threatened us with dire consequences by saying that they will grab our land by any means and if we make any protest, they will not hesitate to ruin our life and property permanently and nobody will do anything against them as they have very good nexus with the high level anti social persons of the locality.

Thereafter, finding no other alternative, we have approached the Ld. Civil Judge (Jr. Divn.) Court at Siliguri and filed a Suit against them vide T.S. No. 24 of 2021 and they have also put their appearance in the said suit and the said suit is still pending before the Court of Law but inspite of having knowledge about the

pendency of the said suit with respect to our aforesaid landed property, the aforesaid miscreants with ill motive have been continuously creating disturbance for smooth enjoyment of our aforesaid land and threatening us with dire consequences to withdraw the aforesaid case and on being refused, they told us that they will come again and capture our entire land forcefully and thereafter, on 09.12.2022, I have lodged a written complaint before your good office.

Sir, today, the aforesaid miscreants along with their engaged anti social persons are again trying to construct a pucca boundary wall encroaching our land including the land of public common road, forcefully and most illegally and seeing the said situation, when I went to the spot and made protest against their said illegal construction, said Debabrata Dhali and Subhadeep Banerjee in connivance with Smt. Rupashree Banerjee and Ankita Dhali, attacked upon me physically and also tried to molest me by touching my body and torn my wearing apparels in public place intentionally and when I started to hue and cry, my husband came there and tried to save me from their hands and at that time, the aforesaid persons and some others attacked upon me and my husband with the construction bricks and iron rods forcefully with an intention to kill us but somehow, we managed to flee away from the spot in order to save our life and they have also threatened us that nobody will save us from their hands and due to their said attack, we have received severe injuries on our person and thereafter, treated ourselves at Siliguri District Hospital.

Sir, the aforesaid persons are very dangerous in nature and they have no fear of law and they have been doing such type of illegal activities on being influenced by some other anti social persons and we apprehend that at any point of time, they will attack upon us and kill us for their wrongful and illegal gain.

I, therefore, request you to investigate into the matter and please take strong legal steps against said **Debabrata Dhali, Subhadeep Banerjee, Smt. Rupashree Banerjee, Smt. Ankita Dhali and others** as per the provision of law and obliged thereby.

Your early action is highly solicited.
