In producing herewith one accused person named Mithilesh Kumar (28y/M), S/O- Bhunni Sah of Fatehabad, Ps. Paru, Dist. Muzaffarpur (Bihar) under arrest along with following articles under proper seizure.

(i) Eight (08) bottles of Kanchan Deluxe Brandy, each bottle containing 750 ml, each bottle MRP- 194 rupees (Total 06 liter). Blended & bottled by Kanchanjunga Distilleries & Liquors, Manipur, South Sikkim marked as exhibit A (Out of which one has been taken as sample for examination marked as exhibit A1) and (ii) 8(Eight) bottle Millenium XXX RUM , each bottle containing 750 ML, MRP- 195 each, Blended & bottled by Mount Distilleries Ltd, Mazitar, Rangpoo, Sikkim. marked as exhibit B (Out of which one has been taken as sample for examination marked as exhibit B1)

I, ASI Manoj Kr. Roy of Pradhan Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Mithilesh Kumar (28y/M), S/O- Bhunni Sah of Fatehabad, Ps. Paru, Dist. Muzaffarpur (Bihar) to the effect that today on 13.12.2022 at 21.15 hrs received a source information that one person is waiting with huge illegal liquor at Siliguri Junction under Pradhan Nagar Police Station without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction I along with CV/992 Jagadish Biswas, CV/242 Rakesh Mangar( All of Pradhannagar Ps) had been to Siliguri Junction under Pradhan Nagar PS to verify the veracity of source information vide GDE no. 763, Dt. 13.12.22. On reaching there and as identified by the source found that one person was waiting with huge illegal liquor. Subsequently, I along with my force able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above and stated that he is the owner of this alcohol . Further being searched the above noted seized articles were found in a cartoon. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain. Then I seized and labelled the above mentioned illegal illicit distilled liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named Mithilesh Kumar (28y/M), S/O- Bhunni Sah of Fatehabad, Ps. Paru, Dist. Muzaffarpur (Bihar) after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 21:35 hrs to 21.55 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Mithilesh Kumar (28y/M), S/O- Bhunni Sah of Fatehabad, Ps. Paru, Dist. Muzaffarpur (Bihar) under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
