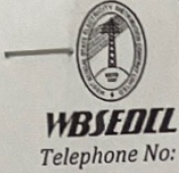

Sir,

I, Suman Sengupta, Son of Ashoke Sengupta, D.E & SM Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India do here by lodge this complaint against Sri Krishna Roy, (Ph- 8597265024), Son of Lt Shyam Lal Roy, Resident of Chayan Para, Near Yuba Sangha Club, Sevoke Road, Siliguri, Dist- Jalpaiguri, P.S Bhaktinagar, West Bengal. And Sri Pradipta Sarkar (Ph- 7866075089) , Son Of Late Tara Pada Sarkar, residing at M.N Sarkar Road, Mahananda Para, Ward No 6 of Siliguri Municipal Corporation, P.O and P.S Siliguri, Dist Darjeeling. While on a routine inspection on the site having consumer id.400694223, meter no IPB249294, having power connection by WBSedcl in the name of Sri Krishna Roy in the address being Chayan Para, Near Yuba Sangha Club, Sevoke Road, Siliguri, Dist- Jalpaiguri, P.S Bhaktinagar, West Bengal, I, Suman Sengupta, Divisional Engineer & Station Manager, Power House CCC along with Sri Jotiska Sengupta , Sr O.E, Power House CCC, WBSedcl and other technical staffs observed that the terminal seal of the meter was broken and energy was being used bypassing the energy meter via direct hooking from service cable and was being enjoyed in an unauthorized manner via an energy meter (L&T make, SI/-99863153) not a property of WBSedcl.

We entered the premises at 1427 hrs on 13.12.2022 after handing over Notice to Sri Krishna Roy. Then it was observed that the power was being used in an unauthorized manner via directly bypassing the energy meter by breaking the terminal seal of the energy meter via direct tapping from the service cable, and was being used via a locally purchased Energy Meter which is not a property of WBSedcl. Therefore committing a crime for theft of power as per section 135 (1) (b) of The Electricity act 2003 amended on 2007 of India. A maximum Demand of 4.61 Kva was found recorded in the energy meter. The power via the un authorized energy meter was being used for an advertisement banner, Which as per the rent agreement attached, is owned by Sri Pradipta Sarkar and to whom, Sri Krishna Roy had rented the place. And as informed on site Sri Pradipta Sarkar was well aware of the fact that the power was being used via the unauthorized meter to power his advertisement banner. Therefore committing a crime of abetment as per section 150 of the Electricity act 2003 amended on 2007 of India. Accordingly the connection was disconnected and the energy meters and service cable were seized and labelled. A copy of both inspection report and Seizure list (1. Bentec make, 1 Phase, (240 Volts), (5-30) amps, SI No IPB249294, property of WBSedcl, 2. Service Cable of Black Color, 10 Sq mm, Single Stranded, Double Core Aluminium wire of 10 meters approx, & 3. L&T make, 1 Phase, (240 Volts), (5-30) amps, SI No 99863153, NOT a property of WBSedcl,) were handed over to Sri Krishna Roy. We exited the premises on 1500hrs.

Thus you are requested to kindly initiate an investigation against Sri. Krishna Roy under Section 135 (1) (b) of the Electricity act 2003 amended on 2007 of India And Sri Pradipta Sarkar under Section 150 of the Electricity act 2003 amended on 2007 of India.
