Dear Sir,

I, Smt. Sanjita Roy, W/o. Sri Jagadish Roy, presently residing at Haider Para, Pritilata Sarani, P.S Bhaktinagar, Dist. Jalpaiguri, would like to inform you that, on 18.02.2018 I entered into the marriage with Jagadish Roy, S/o. Late Jiten Roy, resident of Gital para, Isckon Mandir Road, P.S Bhaktinagar, Dist. Jalpaiguri, according to Hidnu Rites & Customs from the rented house situated at Lower Bhanu Nagar, P.S Bhaktinagar, Dist. Jalpaiguri. It is needless to mentioned here that since my childhood my grandmother takes care of me and my younger brother.

I would like to further inform you that, at the time of my marriage, my grandmother along with my father had given a sum of Rs. 1,00,000/- (Rupees One Lac Only) as per the demand and pressure of my husband and his family members alongwith One wooden Box Khat, One Showcase, one Wardrobe, one dressing table, Gold ornaments about 25 gms. and other brass and steel utensils. After the marriage my husband brought me in his house and we started to reside together as husband and wife there. Thereafter, I started to notice that my husband is a habitual drinker and almost every night he used to come in an intoxicated condition and used to beaten me with fist and blows. Every time he used to slung languages upon my grandmother and my younger brother. Finding no other alternative I left my husband's place on 12.09.2020 and started to live together with my grand mother and younger brother in a rented place situated at Haider Para, Pritilata Sarani, P.S Bhaktinagar, Dist. Jalpaiguri. But very surprisingly my husband came to the place of my rented house and started to abusive filthy languages. Almost every alternative week he came with very drunken condition and used abusive languages.

I would like to further inform you that, on 10.12.2022 my husband came to my rented place and started to threatening me and when my grandmother protest him, she also been beaten. I have no other alternative to come before you and lodge this complaint.

Under the above circumstance I would like to request you to investigate the matter and do needful according to the law.
