Sub: - F.I.R. against my husband Sri Bikash Chakraborty, for Cruelty, for Causing mental and physical torture in order to maintain illicit adulterous relation and also for Attempt to Murder due to non-accepting their illegal relation.

Respected Sir,

With due regards, I, **SMT. RUMA CHAKRABORTY**, Wife of Sri Bikash Chakraborty, Daughter of Late Ganesh Chandra Nandy, Resident of Hakim Para, Atul Prasad Sarani, Ward No. 15 of S.M.C., Siliguri, P.O. & P.S. Siliguri, Dist. Darjeeling, Pin: 734001, would like to lodge this written complaint to the effect that in the year of 1987, my marriage was solemnized with **SRI BIKASH CHAKRABORTY**, Son of Late Birendra Nath Chakraborty, Resident of Hakim Para, Atul Prasad Sarani, Ward No. 15 of S.M.C., Siliguri, P.O. & P.S. Siliguri, Dist. Darjeeling, Pin: 734001, according to Hindu Rites and Customs, after observing all formalities of a Hindu Marriage. It is to be mentioned here that our marriage was the outcome of our previous love and affairs and after our marriage, my husband brought me at my matrimonial house situated at Jyoti Nagar, Phansidewa, Dist. Darjeeling, where we started to live and cohabited together as husband wife for a period of 04 years and out of our wedlock, one male child was born on 18.09.1989, whose name is Sri Bidurin Chakraborty and one female child was born on 15.03.2000, whose name is Barnita Chakraborty and presently, both of them are residing at Bangalore for the purpose of their respective jobs.

After our marriage, we have passed our marital life happily and peacefully and basically, there was no problem from my side as well as from the side of my husband. After passing few years at my matrimonial house, we have shifted at Haider Para, Siliguri as per the request of my husband and started to reside there as husband and wife along with our children. After leaving my matrimonial house, I have noticed some changes in the attitude and behavior of my husband. He started to consume alcohol on regular basis and used to return back home at late night and as and when, I asked him about his such type of activities, he did not bother to assault me physically but considering our long standing martial relation as well as the social prestige, I used to keep mum and bear all such type of inhuman torture of my husband with a hope that in future, he will definitely realize his own mistake and thereby, rectify himself but all my hopes gone in vain.

Thereafter, I along with my husband have jointly purchased a Flat at Hakim Para, Atul Prasad Sarani, Ward No. 15 of S.M.C., Siliguri, P.O. & P.S. Siliguri, Dist. Darjeeling, and subsequently, shifted in the said Flat at Hakim Para in the year of 2015 and started to reside in the 1st floor of the said flat along with my husband.

It is very painful to mention here that since after shifting in the said Flat at Hakim Para, Siliguri in the year of 2015, I have found and noticed some abnormal activities and behavior in the nature and character of my husband. He became more furious day by day and started to misbehave

with me without any just cause and reason and on contrary, he used to abuse me with filthy and abusive languages.

Madam, in the Ground Floor of the said Flat, one Pintu Kundu and his wife Smt. Soma Kundu have been residing there and said Pintu Kundu being a business person, used to leave the house at early morning for the purpose of his business and returned back home at late night on regular basis and during that period, his wife Smt. Soma Kundu being a housewife, used to stay at home alone with her minor son.

After our shifting in the 1st floor of the said Flat, in the year of 2018, I along with my daughter went to Kolkata for the purpose of her studies and stayed there for a period of one and half years and during that period, my husband resided in our Flat alone and every after 2/3 months interval, I used to visit at Siliguri but as and when, I came to Siliguri, my husband shows his unhappiness towards me and very surprisingly, during that time, I have noticed that said Smt. Soma Kundu in absence of her husband, used to visit our flat on regular occasion on different excuse and used to mix up and spend times with my husband personally and as and when, they got the opportunity, they used to talk with each other over phone for hours and hours and when I asked and requested my husband not to talk with the said lady, he did not pay any heed to my said request.

After my returning at Siliguri from Kolkata, I have found and noticed excessive adulterous activities in between my husband and said Smt. Soma Kundu and when I make protest against their such type of illegal activities, they told and confessed before me that they have fallen love with each other and they wants to maintain their extra marital relation in future also and I have to accept their said illicit relation otherwise, they will not hesitate to ruin my life permanently. Thereafter, I have tried my level best to understood my husband not to behave in such a manner and relinquish the said relation with the said lady at least considering our long standing marital relation as we have already passed our marital life for more than a period of 35 years but he did not pay any heed to my request and on contrary, he started to threaten me with dire consequences and forced me to accept their said illicit relation otherwise, they will not hesitate to kill me.

Day by day, they have increased the parameter of their illicit adulterous extra marital relation and as and when, the husband of said Soma Kundu left the house, she called my husband in her room and mixed up with each other and in one occasion, the other inhabitants of the said flat caught them red handed in compromising situation in her room and thereafter, I have informed the said matter to the family members of Smt. Soma Kundu but no fruitful result occurred. Finding no other alternative, I along with the other inhabitants of the said flat, informed the matter verbally to the Councilor of Ward No. 15 of SMC as well as the Secretary of Royal Sporting Club with a request to intervene into the matter and thereafter, in presence of the Councilor and other dignitaries, several Salishi were made but my husband and said Smt. Soma Kundu were/are very reluctant with their said acts and activities and forced me to leave the house and on being refused to leave the house, my husband in conspiracy with said Smt. Soma Kundu have assaulted me physically by pulling my hair logs with an intention to oust me from the house forcefully and thereafter, finding no other alternative, I have lodged a written complaint before your good office and on the basis of the said written complaint, one specific case has been initiated vide Siliguri Women P.S. Case No. 88 of

2022, Dated: 25.05.2022, U/S - 498A/323/506 of I.P.C. and since then, I have compelled to reside in a separate bedroom of our said flat as he has flatly refused to accept me with him in order to maintain his extra marital relation with the said lady and since then, my husband in conspiracy with the said lady, has been creating mental torture upon me continuously in order to oust me from the house.

Madam, yesterday i.e. on 10.12.2022 at about 10.15 P.M., after consuming alcohol, my husband started to ransack the household articles of our house and abused me with filthy and abusive languages and created the atmosphere of our flat obnoxious without any just cause and reason though, I have been residing in a separate bedroom and due to his such type of activities in the flat, when I made protest against him, he became more furious and started to beat me with fist, blows and number of kicks on my body and due to his inhuman assault, when I started to hue and cry, he picked up a sharp cutting knife from the kitchen and tried to attack upon me with the said sharp cutting knife with an intention to Murder me but somehow, I rescued myself from his hand and locked myself in the room and informed the matter to my Brother-In-Law Sri Gopal Dey over phone and knowing the said fact, my Brother-In-Law came to my room and rescued me.

Due to the sudden attacked of my husband, I have received severe injury on my person and thereafter, I went to the Siliguri District Hospital for necessary treatment and the attending Doctor treated me and performed a City Scan and after examination, the Doctor prescribed me some medicines and since then, I have been passing my days with extreme fear and anxiety and I also apprehends that my husband in conspiracy with the said lady Smt. Soma Kundu may again attack upon me in order to kill me.

I, therefore, request you to kindly investigate into the matter properly and please take appropriate strong legal action against my husband and said Soma Kundu as per the provision of law and obliged thereby.
